The 2022-2023 annual District 6270 business meeting was called to order by DG Mike Phillips at 10:15 AM

District Board Members at the meeting were: DG Phillips, PDG Werner, DGE Griffing, DGN Bosch, PDG/DFCC Sanderhoff, PDG Burnett, Treasurer Danner, Secretary Koop, Rotaract Representative Ruedinger, Trainer O'Halloran.

Explanation and test of Mentimeter electronic voting procedures was done by DG Phillips and DGE Griffing.

Call for changes to Agenda, by DG Phillips, introduction of district RYE students was added to the meeting agenda. Harry Farchim moved to approve the agenda with the change, Jane Ipsen, seconded the motion. Motion passed.

Cindy Petted moved to approve the 2022 annual district business minutes, seconded by Rob Bassett. 28 votes cast in favor. Motion passed.

Treasurer Danner mentioned the Hawkins Ash report and spoke about the district's financial status. With change in Treasurers, from Swetlik to Danner, a different bank was gotten for the district – Associated Bank. Moving forward with electronic methods, so clubs can remit funds electronically. Mary Beth Seiser moved to accept the Treasurers report with a second by Rick Debe. 38 votes cast in favor. Motion passed.

DGE Griffing presented the proposed district budget for 2023-2024. Highlighted that was no dues increase as compared to other districts, previous budgets have been under projected for the years past. No questions raised. Motion made by Jane Ipsen to approved the 2023-2024 district budget, seconded by Shelly Higgins. 30 votes cast in favor. Motion passed.

By-law changes, recommended by the Governance Committee presented by committee chair PDG Sanderhoff for approval, – Articles 2.01, 3.05.01, 4.03, 5.08.02, 8.02, 3.02.01, 4.02, 5.11, 8.04. Motion by Harry Farchmin with a second by John Henderson to approve the by-law changes. 36 votes cast in favor. Motion passed.

Nominating committee co-chairs PDG Burnett and PDG Werner reported that Liz Nevitt, of the Rotary Club of Ripon was selected as the District Governor for 2025-2026, by the Nominating Committee. 37 votes in favor. Motion passed.



Nominating committee co-chairs PDG Burnett and PDG Werner reported that PDG Rick Debe, was selected as the District's COL/COR Representative Delegate. 39 votes in favor. Motion passed.

Nominating committee co-chairs PDG Burnett and PDG Werner reported that PDG Jeff Reed was selected as the COL/COR Alternate Representative Delegate. 38 votes in favor, with 1 abstaining. Motion passed.

Jeff Reed, WAS Board President, spoke about the WAS resolution of District support and that funding be continued at least at the current level of \$8,000. Resolution about World Affairs Seminar (WAS), 32 in support, 4 voting no. Resolution passed.

District Rotary Youth Exchange delegates, 7 inbound and 2 outbound did self-introductions to meeting attendees.

Representative Angela Rester, gave a report on Council on Legislation/Resolutions, she highlighted some of the recent actions: member of Rotary no longer needs to live in the locality; takes 15 new members to start a club; word "retired" can be added to a person's classification; action can be taken to strip off officer status. One can review actions of the CoL/CoR in 'My Rotary'.

DG Mike Phillips, highlighted some actions and activities during his year as District Governor: 3 Disaster relief grants to Ukraine, website updated, new club in Union Grove a cause-based club – a satellite of Mukwonago Rotary, Foundation committee reaching and exceeding goals.

DGE Don Griffing, shared some of his outlook and plans for 2023-2024 Rotary year, increasing impacts in our communities and expanding our reach. Getting back to pre-Covid levels; making the Rotary Foundation, the charity of choice; Positive Peace; taking care of our mental health; work on creating lasting change in our communities. Rotary Day of Hope on February 29th; greater AG support; changes with website; create more personal connections; all volunteers need balance.
