### **General Description**

The investigation of child abuse can be difficult for all involved. Families must contend with both the civil and criminal justice systems, which can be complex, confusing and often retraumatizing. Civil and criminal investigators face challenges as they try to collect information and evidence while working under different mandates, timelines and expertise. Investigators need a system that coordinates information sharing and effective fact finding. One of the critical services provided by the CAC (Child Advocacy Center) is forensic interviewing. The audio/video recording of these interviews eliminates the need for multiple interviews of the child, thus reducing trauma to the abused child.

Although the CAC will house, use and maintain to equipment to be provided by the proposed grant, the intended beneficiaries of our proposed grant will be abused children in their time of need. We intend to reduce/eliminate the need for these children to re-tell their horrific experience.

### **Community Assessment & Impact**

The benefiting community was determined using historical data (2013) provided by the Children's Advocacy Center of Hidalgo County. On average 80-85 children receive services from the CAC on a monthly basis. In 2013, the CAC served 964 new victims which range from 2 to 17 years in age. We anticipate that over 7,000 abused children and their families will benefit over the course of our proposed grant. Interviews of child victims are conducted for allegations of sexual abuse and/or physical abuse; allegations of neglect; or as witnesses to a violent crime. 70-75% of interviews are child victims of sexual abuse.

## **Sustainability**

The proposed grant will fund the much needed audio/ video equipment to be housed, used and maintained by the Children's Advocacy Center of Hidalgo County. We estimate the useful life of this equipment to be 7-10 years. Given the statistical information provided, we believe the beneficiaries of this grant will be roughly 7,000 abused children and their families. The proposed grant includes a budgeted line item for training and proper use of equipment. The Rotary Club of McAllen South will conduct annual inspections of equipment to ensure proper maintenance and require immediate notification from CAC in the event of equipment malfunction.

#### **Implementation Plan**
