

The Rotary Club of Silver City held a fund raising reception. PDG Kit Turpen spoke and showed a couple of inspiring videos. The club raised over \$3,400 for Polio Plus.

The Rotary Club of Los Alamos held a fund raiser with the local elementary schools called a "Purple Pinkie Polio Plus Project". School children who donated \$1.00 and had their pinkie painted purple to show support for Polio Plus. The club received excellent public relations in local media.

George Basch: Taos Rotarian a saver of lives

eorge Basch of the Taos-Milagro Rotary Club is more than an adventurer, explorer and tax guru, but he also helps save lives — by the thousands. As a

many-times climber of Mount Everest (at least up to the 17,500 feet above sea level base camp), he fell in love with the Himalayan peoples and learned of the tragedies of not only earthquakes but the four million who die each year because of wood cooking stoves that create serious breathing problems. So he founded the Paul Basch Memorial Foundation, named for his late son and fellow Mount Everest climber, which has now provided





more than 4,000 clean-air stoves to villages throughout Nepal. He found a supplier of the Envirofit cook stoves in Fort Collins, Colo., costing only \$150 each. It not only drastically reduced deaths from pollution, but freed up children to go to school instead of having to help transport wood every day for their old wood fire stoves. George said Rotary clubs from around the

world contribute to his humanitarian effort, including those in Nepal. In fact, the club in Kathmandu, Nepal, did a survey among families who had received the clean -air stoves and found that the new stoves reduced smoke and harmful gasses by 90%, reduced the need for wood by 75%, and reduced cooking time up to 50%. Said George: "The Himalayan people who now cook on non-polluting stoves wouldn't give them up for a million rubles."

Alumni Relations: Don't forget parents of our "alumni"

A lumni relations is a job that requires some imagination. Many of our youngest "alumni" (RYLA and Foreign Exchange Students) move around faster than our data bases. But, there's another way of thinking about Rotary Alumni that may just help us build Rotary brand awareness and membership at the same time.

Let's think of Alumni as not just the interactors, RYLA graduates and Rotary Youth Exchange members but their families as well. By capturing their email information and including them in your newsletter distribution and club information, you will be educating them about Rotary and helping them spread the word about who we are and what we stand for. They may even decide that they want to join a Rotary Club.

- Put the parents of your outbound students on your Rotary "friends" mailing list.
- Ask your returning students to stay involved in Rotary as they move around the Country (or World). Rotary is for "life." Ask them to keep their My Rotary information current.
- Keep your lapsed Rotary members on your communications list. As we left the Rotary meeting today, Tom Simon and I met a former Rotary member who "has time now" and really wants to reconnect himself (and his wife) to Rotary.

Foundation eTraining set for December 10

Changes in upcoming year a hot topic for Foundation chairs

egistration remains open for this impact-fact-filled Foundation eTraining conference set for Saturday, December 10, starting at 9 a.m. Particularly to Club Foundation Committee Chairs and Club President-Elects E(or Nominees) are changes to the methodology used in the District Grant Funding model for FY 18 (2017 –2018) as well as the FY 18 Grant planning dates.

In the past, the model used for distributing the funds for District Grants has been relatively simplistic. The funds that support the District's matching grants program are a substantial portion of The Rotary Foundation (TRF) annual grant to District 5520. The total received by District 5520 is equal to 50 percent of the amount donated by District clubs to TRF three years prior to the funding year. Simply, during FY 2018, the TRF will return to District 5520 half of the money that the D5520 Clubs donated to TRF in FY2015. This portion of the District's grant funding model remains unchanged.

What will change for the upcoming Rotary year will be how the matching funds will be distributed to those clubs applying for a grant. This will be a major topic of the December 10 eTraining.

Until now, given the amount of funds available to D5520 for grants to support club projects throughout the district., clubs would submit their grant applications and, upon approval, receive from \$250 to \$2,000 in matching funds from D5520. There was no attention paid to the amount contributed by the club to TRF three years prior. So, a club that contributed nothing to TRF three years earlier could still apply for and get a District grant of up to \$2,000. Effective FY18 (i.e., 1 July 2017), the District Grant Fund Distribution model is being changed to "make it fair for all concerned."

Additionally, we will be discussing advancing the dates for clubs applying for District Grants so that the funds can be distributed much earlier in the Rotary year than we have done in recent years. The goal would be to distribute funds in the July-August time frame. This means that present incoming club senior management and boards of directors will need to be planning NOW for their club's projects and making an application for a district matching grant before they take office. Again, details of this schedule change will be discussed at the December 10 meeting. See you there!!

Selecting a District Governor Nominee

Qualified candidates need to be nominated by February 10

ach year one of the most important responsibilities of a Rotary District is the selection of the District Governor Nominee. This selection must take place 24 to 36 months before the selectee will assume office as District Governor. PDG Tom Walker, as District Nominating Committee Chair, is soliciting the help of each club in recommending qualified candidates for District Governor to the District Nominating Committee. The committee will meet to select the 2017-2018 District Governor-Nominee at President-Elect Training (PETS), February 23-25, 2017 in El Paso. He suggests that each President lead their club in seeking out and nominating the best-qualified person for the office of governor.

At the time of selection, the nominee will be called Governor-Nominee Designate and will assume the title of Governor-Nominee on 1 July two years before serving as Governor. The Governor-Nominee must:

- Be a member in good standing of a functioning club in the district (RIB 16.070.1.)
- Have full qualifications for such membership in the strict application of the club membership provisions therefor, and the integrity of the Rotarian's classification must be without question (RIB 16.070.2.)
- Have served as president of a club for a full term or be a charter president of a club having served the full term from the date of the charter to 30 June, provided that this period is for at least six months (RIB 16.070.3.)
- Demonstrate willingness, commitment, and ability, physically and otherwise, to fulfill the duties and responsibilities of the office of governor as provided in RI Bylaws section 16.090 (RIB 16.070.4.)
- Demonstrate knowledge of the qualifications, duties and responsibilities of Governor as prescribed in the RI Bylaws, and submit to RI, through its general secretary, a signed statement acknowledging a clear understanding of them. This statement shall also confirm that the Rotarian is qualified for the office of governor and is willing and able to assume the duties and responsibilities of the office and to perform them faithfully (RIB 16.070.5.)

Additionally, a governor must have attended the international assembly for its full duration, been a member of one or more Rotary clubs for at least seven years and must continue to possess the qualification in section 16.070 (RIB 16.080)

Clubs recommending a club member to the District Nominating Committee must submit the attached Governor-Nominee form and Information Sheet as well as a resume and a listing of the candidate's significant Rotary service and activities. These documents must be received by District Nominating Committee Chair PDG Tom Walker by **5:00 PM, Friday, February 10, 2017**.

News Briefs ... from the District Office

Changes to Rotary Grant Application Tool

In December, the Grant Application Tool on the Rotary.org website will be renamed the Grant Center and will feature a new look, more streamlined application process and for those of you who feel the need for speed like I do, faster load times.

Expect significant changes. For those of you with grants in progress, there are things that you can do to make your job easier. To begin with, generate a PDF of your full grant before a planned outage of the Grant Application Tool which is scheduled to take place on December 3-5 and again on December 12-13. Although Abby McNear, Rotary Grants Manager, reports that existing applications will be adjusted to fit the new structure, generating a PDF of your full grant will ensure easy access to the details of your grant in a familiar format. In addition, if you have documents uploaded to the current system that you don't also have saved on a local computer, I suggest that you download those documents even though it is reported that they will still be available in the new system.

In some cases, authorizations required for grants will need to be made by email to The Rotary Foundation's Grant Coordinator rather than on-line. If you can obtain authorizations on-line prior to the change, it will likely make the process quicker and easier.

It was repeated several times in notes from the foundation regarding these changes that vocation training teams, members and documents will not be displayed in the new application but will be retained by the foundation. Therefore, be sure to document this aspect of your grant, if included, prior to December 3rd.

As the District 5520 Global Grants Chair I will continue to monitor and learn about the Grant Center so that I can assist you with any questions that you may have along the way.
