

Area 1 is located in the mountains of Plumas and Lassen counties and includes the Susanville high desert area. The four clubs comprising Area 1 have more than 200 years of service to community: Susanville, chartered in 1926; Westwood in 1937; Chester in 1992; and Susanville Sunrise in 2002. Three clubs celebrate significant anniversaries in 2012: Westwood has been serving their community for 75 years; Chester has a 20 year service history; and our newest club, Susanville Sunrise reaches their 10 year milestone.

March is our month to focus on *Literacy* programs. We are three fourths of our way through our Rotary year and looking forward to Spring and plans for a new Rotary year. One of the best aspects of Rotary is that it encourages each club to be unique and to define their goals and projects with their communities in mind.

The Chester Club celebrates Literacy month with a Dr. Seuss birthday reading and book give away to the 2nd graders at Chester Elementary. The club will continue its monthly reading and book donation to the kindergarten class. This project is shared with other Plumas County clubs and is in its third year. The speech contest, although held in February spotlighted literacy through the hard work and professional presentation from seven contestants representing two schools. Kudos to chair Dennis Gomez. The club continues to be passionate about youth programs and supports an Interact club, two outbound RYE students, one RYE inbound, sponsors two RYLA students and awards three annual scholarships for academic, vocational and continuing higher education. Special thanks to Cheri McIntire RYE counselor and Gina Pixler Interact Advisor. The club is putting a DSG to work in partnership with the County and other local businesses to complete an irrigation and landscaping project at the newly completed Community Recreation Center. In May, the club will sponsor the Memorial

Week-End Craft Fair at Chester Park for the third year. This two day event really put the *fun* back in *fun*draising. July 4th will find Chester and Westwood Rotarians selling duck race tickets for the Feather River Duck Derby that

follows the local parade. July 28 is the third annual Mid-Summer Madness event at Foxwood Pavillion near Lake Almanor. This food, wine, beer & spirit tasting event is the top fundraiser of the year and a party not to be missed. This year the club will partner with the local Chamber of Commerce to enhance the event. A small morning club, Chester has been enjoying inspired fellowship at regularly planned old fashioned potluck dinners. This has become a real favorite of members. President-elect Joe Cummings is headed for PETS and a year of Peace Through Service.

Westwood is an ever shrinking, old logging community. The Rotary Club of Westwood has a 9 member roster small but mighty and amazing. After 75 years, they are employing their first ever DSG to support their Breakfast for Kids Program which serves a hot breakfast to the 80+ elementary school kids on the second Tuesday of each month. In addition to the speech contest, they sponsor a RYLA student and are involved with the local Boy Scouts. They host the Annual Easter Egg hunt with 90 dozen good old fashioned colored eggs and also sponsor an Easter poster coloring contest for elementary age kids. Opening day of Little League finds these dedicated few serving up breakfast burritos and juice to about 120+ kids and parents. Summer kicks off with their annual painting of all the white parking lines in front of businesses, including the Senior and Resource Centers as well as keeping the George Young Rotary Park maintained. Academic and Vocational scholarships are awarded each June, they prepare 10-12 food baskets for families in need for both Thanksgiving and Christmas, and for 35 years, Santa has made an annual visit to the elementary and pre-school for official lap sitting, bags of holiday treats and fresh oranges. Santa is of course - a Rotarian. Their traditional fundraisers include the February Crab Feed, a Cinqo de Mayo bar, July 4 Duck Race with Chester, Old-Timers/New-Comers Picnic in August - a major undertaking, and Winter in the Mountains Hot Beverage Booth. Talk about Service Above Self! My hats off to the Westwood club – they never cease to amaze me and their commitment to their community in the name of Rotary. Current President John Cox will serve a second year.

Susanville is Area 1's oldest club. Incoming Assistant Governor Penny Artz is a member of this venerable club. After 86 years, they too are putting their first DSG into action: a remarkable literacy project which serves 4 schools with ongoing classroom reading by Rotarians and donating over 1000 books to students. Youth are the focus with continued student of the month recognition and RYLA camp participation. President Bob Burns turned the Rotarians at Work day into a year long event in con-

junction with the Sunrise club. The first or second Saturday of each month finds the clubs working on a small service project around the community and following up with fellowship and a BBQ. Ongoing, they place American Flags along Main Street for various holidays. A rich history in ranching, they host the Annual Cattleman's Luncheon inviting other Rotary clubs to attend and at Christmas, they host a party for local children. As the two Susanville clubs draw from one high school, the clubs alternate who hosts the speech and music contests and then hosts the area competition. This year, Susanville will host the speech contest. President –elect Fred Autenreib is on his way to PETS.

Susanville Sunrise is a dynamic young club committed to the Foundation in a big way. Their 9th annual Foundation Dinner was held on 2/24 where they presented nine Paul Harris Fellows. This 10 year old club has donated over \$100K to the foundation with a per capita donation exceeding \$200 every year. They recently sponsored the blood drive for United Blood Services, cut and stacked wood for seniors, and packed Christmas packages for Food 4 Families. They are hosting an RYE student from Thailand and recently inducted a couple of new members. Their annual fall Wine Tasting fundraiser was followed by a Win a Trip for two to Maui. Members have joined Susanville for monthly RAW days and will be sponsoring the local and area music contest. President-elect Michelle Zubillaga will join fellow Rotarians at PETS.

The Visionaries are coming. May the good work of Rotary continue in your hearts and communities. Many thanks to Area 1 clubs and the DG's I have served for enriching my experience of Rotary as your Assistant Governor.
