# AWARDS THAT RECOGNIZE MEMBERS

#### SERVICE ABOVE SELF AWARD

can receive the award only once.

The Service Above Self Award is considered the highest honor that RI can bestow on a member. It recognizes up to 150 outstanding Rotarians and Rotaractors each year whose service activities make an impact on humanity. No more than one recipient is selected from a given district each year, and a person





Nomination process: Current governors and RI directors can nominate one candidate from their district using this online nomination form. RI's

current special representatives to non-districted Rotary clubs may also nominate one member per year from the group of non-districted clubs they serve. All eligible nominations will be reviewed by a review committee for recommendation to the RI Board for selection. Their recommended recipients are presnted to the RI Board for approval at their January meeting, after which, nominators will be notified.

#### Nomination period: 1-31 October

Eligibility criteria: Nominees must be Rotarians or Rotaractors in good standing, and may not be current, incoming, or immediate past governors, RI directors, RI presidents, or Rotary Foundation trustees. Nominees must have demonstrated exemplary continuing humanitarian service, in any form and at any level. Emphasis is placed on personal volunteer efforts and active involvement in helping others through Rotary, rather than one's performance in an elected or appointed Rotary assignment. Personal financial contributions to Rotary, its Foundation, or any individual project are not relevant considerations for this award.

Award type: Engraved crystal and lapel pin, and an invitation to a private reception at the **Rotary Convention** 

#### **ROTARY FOUNDATION CITATION FOR MERITORIOUS SERVICE**

The Rotary Foundation's Citation for Meritorious Service honors one Rotarian or Rotaractor per district who has been actively involved in service related to The Rotary Foundation.

Nomination process: District Rotary Foundation committee chairs can nominate one candidate from their district by completing this <u>online nomination form</u>. Nominations must be endorsed by the current governor of the nominee's district, and



governors can endorse only one nomination from their district per year. The general secretary reviews nominations to confirm that they have the required signatures and endorsements and that nominees haven't already received the award. Upon confirmation, RI notifies nominators of the results in January or February.

Nomination period: November-December

Eligibility criteria: Nominees must be active Rotarians or Rotaractors in good standing, and may not be current, incoming, or immediate past district governors, RI directors, or Rotary Foundation trustees. You cannot nominate yourself for the award, and a person can receive this award only once. Service to The Rotary Foundation must have been for more than one year. Financial contributions to the Foundation, however notable, are not relevant considerations for this award.

Examples of eligible service include, but are not limited to:

- Service on Foundation committees at the club, district, or international level •
- Participation in Foundation grants or programs
- Support of Rotary Peace Fellows

Award type: Electronic certificate

#### ROTARY FOUNDATION DISTINGUISHED SERVICE AWARD

The Rotary Foundation Distinguished Service Award honors up to 50 Rotarians and Rotaractors who have demonstrated exemplary service to the Foundation and who have received the Citation for Meritorious Service at least four years earlier.

Nomination process: Nominations can be made by any Rotarian or Rotaractor and must be endorsed by the current governor of the nominee's district. The nominee must also be endorsed by a Rotarian or Rotaractor outside the nominee's district. District governors can endorse only one nomination for their district. Current and incoming trustees are not eligible to nominate or endorse candidates for this award. Nominations can be made by completing the online nomination form and including detailed information about the specific Foundation





received the Citation for Meritorious Service. Eligible nominations are reviewed by a review committee and the recommended recipients are presented to the Board of Trustees at their April or June meeting for approval. Once approved, the nominators are notified of the results.

Nomination period: 1 January to 28 or 29 February

activities and responsibilities of the nominee since they

**Eligibility criteria**: Any active Rotarian or Rotaractor in good standing who received the Citation for Meritorious Service at least four full calendar years earlier may be nominated except for current, incoming, or immediate past district governors, RI directors, or Rotary Foundation trustees. You can't nominate yourself for the award, and a person can receive the award only once. Financial contributions to the Foundation, however notable, are not relevant considerations for this award.

The nominee's eligible service must be on a broad basis, over an extended period, including at least six of the following activities, with a substantial level of activity in the past two years:

- Serving on a district Rotary Foundation committee for a total of at least five years
- Providing significant leadership at district or multidistrict Foundation training events
- Presenting about The Rotary Foundation at district or regional events
- Presenting about The Rotary Foundation at more than 20 club meetings within a twoyear period
- Serving as a scholar counselor or host at least three times
- Organizing and carrying out successful fundraising efforts at the district or multidistrict level
- Providing significant leadership in district or multidistrict scholar or vocational training team orientation
- Serving as the designated project contact person on a successful grant project for which a final report has been received
- Providing substantial leadership in PolioPlus projects and activities
- Maintaining contact with alumni and involving them in district activities
- Other special projects or activities, which the nominator clearly defines and describes in detail, in support of The Rotary Foundation

Award type: Engraved crystal and lapel pin

#### ROTARY FOUNDATION DISTRICT SERVICE AWARD

The Rotary Foundation District Service Award honors Rotarians and Rotaractors who are making a difference through the Foundation's programs, promoting the Rotary Foundation and its goals of world understanding and peace.

**Nomination process:** Members are nominated by their clubs to the district Rotary Foundation committee, which forwards these recommendations to the district governor. Governors can approve those recommended and award one or more members with <u>this</u>



<u>certificate</u> at the district conference. The selection is made by the district governor with the input of the district Rotary Foundation committee.

Nomination period: All year, but ideally before district conference

**Eligibility criteria**: Any active Rotarian or Rotaractor in good standing who has demonstrated laudable service in promoting The Rotary Foundation and its goal of world understanding and peace and who is recommended to the district Rotary Foundation committee and selected by the governor. The requisite service does not depend on, but does not preclude, any financial support for The Rotary Foundation.

#### Award type: Electronic certificate

#### AVENUES OF SERVICE AWARD (DISTRICT-LEVEL)

The Avenues of Service Award (district-level) recognizes the efforts of individual Rotarians and Rotaractors in each of Rotary's five Avenues of Service: Club Service, Vocational Service, Community Service, International Service, and Youth Service.

**Nomination process:** Current club presidents can nominate a member for one or more Avenues of Service Awards by completing this <u>online nomination form</u>. See these <u>examples of eligible service</u>

<u>activities</u>. The governor is notified of the nomination and will determine if the achievement is worthy of recognition by certificate. The governor then presents the certificate to the recipient.

#### Nomination period: All year

**Eligibility criteria:** Any active Rotarian or Rotaractor in good standing except current club presidents; incoming, current, or immediate past governors; general secretaries, RI directors, RI presidents, Foundation Trustees, and RIBI presidents, vice presidents, or honorary treasurers. A person can receive each award only once.

Award type: Electronic certificate

#### AVENUES OF SERVICE AWARD (RI-LEVEL)

The Avenues of Service Award (RI-level) recognizes individual Rotarians and Rotaractors who have received recognition in all five Avenues of Service: Club Service, Vocational Service, Community Service, International Service, and Youth Service.

**Nomination process:** A governor can nominate a Rotarian or Rotaractor who has achieved recognition in all five Avenues of Service for recognition by RI by submitting this <u>online nomination form</u>. Nominations are

processed and reviewed for eligibility on the 1<sup>st</sup> of October, April, and July. Governors are

limited to 10 nominations per processing period, or 30 per year. RI then notifies nominators of the results and ships the Avenues of Service engraved crystal and pin to nominators of eligible candidates.

**Eligibility criteria:** Any active Rotarian or Rotaractor in good standing who has earned recognition in all Avenues of Service and who has not previously received this award is eligible.

Award type: Engraved crystal and lapel pin

**MEMBERSHIP SOCIETY VIRTUAL GALLERY** 







The Membership Society for New Member Sponsors honors members who have demonstrated extraordinary dedication and commitment in sharing the gift of Rotary by sponsoring 25 or more prospective members.

**Process**: When a new member is reported to Rotary, a sponsor can be listed.

Members can achieve the following recognition levels:

- Bronze level: Sponsored 25-29 members
- Silver level: Sponsored 30-49 members
- Gold level: Sponsored 50-74 members
- Platinum level: Sponsored 75 or more members

**Eligibility criteria:** Any active Rotarian in good standing who has sponsored 25 or more new members into their own club, and whose sponsorship is reported to Rotary is eligible for recognition. Only new member sponsorships between active members of the same Rotary club are counted.

Award type: The names of these sponsors are listed in our <u>virtual gallery</u> on My Rotary.

#### SYLVIA WHITLOCK LEADERSHIP AWARD

The Sylvia Whitlock Leadership Award honors one member per year who has actively worked to advance women in Rotary. The award is named for the first female Rotary club president, Dr. Sylvia Whitlock, who went on to become governor and led change for women and girls around the world, through Rotary.

**Nomination process:** Rotarians and Rotaractors can submit one nomination by completing this <u>online nomination form</u>. Eligible nominees are reviewed by a review committee that includes past Sylvia Whitlock Award recipients. Only one recipient shall be selected each year.

# Nomination period: August - September

**Eligibility criteria:** Any active Rotarian or Rotaractor in good standing who has demonstrated extraordinary success in the advancement of women in Rotary, regardless of gender or tenure of membership, may be nominated. Members cannot nominate themselves and may only receive the award once.

Award type: Engraved crystal

# SERVICE AWARD FOR A POLIO-FREE WORLD

The Service Award for a Polio-Free World honors Rotarians who have made outstanding contributions to our polio eradication efforts. Individuals can be nominated for regional or international service.



# Membership Society

New Member Sponsors



**Nomination process:** Any active Rotarian can nominate a member by submitting <u>this online nomination form</u>. The general secretary reviews nominations to confirm that nominees haven't already received the award. The International PolioPlus Committee then reviews candidates for eligibility and upon confirmation, forwards their names to The Rotary Foundation trustee chair for approval of regional awards, and to The Rotary Foundation trustees for approval of international awards. Printable certificates suitable for framing are emailed to district governors to present to recipients of the regional award. Bronze plaques are sent to the relevant Rotary International director to present to the international recipient.

#### Nomination period: 15 July to 1 October

**Eligibility criteria:** Any active Rotarian is eligible except current and incoming trustees of the Foundation, current and incoming directors of Rotary International, members of the International PolioPlus Committee, and current and incoming district governors. Any Rotarian who has previously received either the regional or international award is ineligible for the regional awards; previous international award recipients are ineligible for future international awards in PolioPlus. **Award type:** printable certificates for regional award recipients; bronze plaque for international award recipient.

# AWARDS THAT RECOGNIZE NON-MEMBERS

#### ROTARY AWARD FOR EXCELLENCE IN SERVICE TO HUMANITY

The Rotary Award for Excellence in Service to Humanity recognizes up to 150 non-Rotarians who have demonstrated exemplary humanitarian service through Rotary.

**Nomination process:** The district governor nominates one eligible candidate from their district by completing the <u>online</u> <u>nomination form</u>. RI's current special representatives to nondistricted Rotary clubs can also each submit one nomination per year. Eligible nominations are reviewed by a review committee who selects the recipients and the Secretariat then notifies nominators of the results in April or May.

#### Nomination period: 1-31 March







Eligibility criteria: Only non-members, including the spouse or partner of an active Rotarian or Rotaractor in good standing, may be nominated for this award. A person can receive the award only once. Candidates will be considered based on the humanitarian service they have demonstrated through Rotary, with an emphasis on personal volunteer efforts and active involvement in helping others. Personal financial contributions to Rotary, its Foundation, or any individual project are not relevant considerations for this award.

Award type: Engraved crystal and lapel pin

# AWARDS THAT RECOGNIZE ALUMNI

#### ROTARY ALUMNI ASSOCIATION OF THE YEAR AWARD

This award recognizes one Rotary Alumni Association each year that has demonstrated the significant impact of Rotary programs.

**Nomination process:** Any member of the Rotary community (Rotary member, non-Rotarian alumnus, etc.) can nominate a candidate through the online nomination form. Eligible nominations are reviewed by two committees for recommendation to the RI Board and Rotary Foundation Trustees for selection.

Nomination period: 1 July-15 September

**Eligibility criteria:** To be nominated, alumni associations must be formally chartered by Rotary International. They should enhance the awareness of the value of alumni within Rotary, involve a majority of their members in a project or activity over the past year, have an online presence, demonstrate collaboration between Rotarians and alumni, and support the Object of Rotary and Service Above Self.

Award type: Banner (with presidential theme and year)

#### **ROTARY ALUMNI GLOBAL SERVICE AWARD**

The Rotary Alumni Global Service Award recognizes one outstanding Rotary alumnus or alumna each year whose career, activities, and service to humanity illustrate the impact of Rotary's programs.

**Nomination process:** Any member of the Rotary community (Rotary member, non-Rotarian alumnus, etc.) can nominate a candidate through the online nomination form. Eligible nominations are reviewed by the subcommittee of the RI Membership and TRF Awards Review committees for recommendation to the RI Board and Rotary Foundation Trustees for selection.

#### Nomination period: 1 July-15 September

Eligibility criteria: All Rotary alumni are eligible except for current or past RI directors or trustees of The Rotary Foundation. Nominees must have achieved distinction in their profession or vocation, performed sustainable service benefiting the international community, and demonstrated the social benefits of Rotary's programs.

Award type: Engraved crystal

#### AWARDS THAT RECOGNIZE A CLUB

#### **ROTARY CITATION FOR ROTARY CLUBS**

The Rotary Citation for Rotary clubs is the most important award for Rotary clubs. It recognizes clubs that pursue activities that support organizational priorities. The number of clubs that can earn this award is unlimited. A newly chartered club is not precluded from earning this award.

**Nomination process:** A club officer selects at least 50% of the club <u>goals</u> in Rotary Club Central, achieves them with the club during the year, and reports the achievement in Rotary Club Central.

**Nomination period**: Club officers set and achieve goals during their Rotary year. The achievement of the goals must be reported in Rotary Club Central by 30 June.

**Eligibility criteria**: Clubs must be in good financial standing, meaning they must pay both dues invoices within 60 days of receiving the invoice. Club must also show they have achieved at least 50% of the goals in Rotary Club Central. Even if clubs achieve these goals, they aren't eligible if their achievement isn't reported by 30 June.

Award type: Electronic certificate

#### **ROTARY CITATION FOR ROTARACT CLUBS**

The Rotary Citation for Rotaract clubs recognizes clubs that achieve a set number of goals during a Rotary year. The number of clubs that can earn this award is unlimited.

**Nomination process:** A club officer selects at least 50% of the club <u>goals</u>, achieves them during the year with the club, and reports the achievement by completing this <u>online</u> <u>nomination form</u>. The sponsor club president can also submit the form. Upon submission, if all requirements are met, a link to the certificate is sent to the individual submitting the nomination form.

**Nomination period**: Club leaders set and achieve goals during their Rotary year. The nomination form must be completed and submitted by 30 June to be recognized for the Rotary year.

**Eligibility criteria**: Clubs must achieve at least 50% of the goals and submit the online application. Even if clubs achieve these goals, they aren't eligible if the nomination form isn't submitted by 30 June.


Award type: Electronic certificate

#### **ROTARY CITATION FOR INTERACT CLUBS**

The Rotary Citation for Interact clubs recognizes clubs that achieve a set number of <u>goals</u> during a Rotary year. The number of clubs that can earn this award is unlimited.

**Nomination process:** The Rotary sponsor club president completes this <u>online nomination</u> <u>form</u> showing the club's achievements. Upon submission, if all requirements are met, a link to the certificate is sent to the individual submitting the nomination form.





**Nomination period**: The nomination form must be completed and submitted by 15 August for the Rotary year that ended 30 June.

**Eligibility criteria**: Clubs must achieve at least 50% of the goals and submit the online application. Even if clubs achieve these goals, they aren't eligible if the nomination form isn't submitted by 15 August for the Rotary year that ended 30 June.

Award type: Electronic certificate

#### SIGNIFICANT SERVICE AWARD

This award recognizes Rotary and Rotaract clubs for projects that made an impact and gives district recognition to club activities that address a significant problem or need.

**Nomination process:** Club presidents can use the <u>online nomination</u> form to send a project description to the district governor for any project carried out during their year of service. The governor is notified of the nomination and determines whether the achievement is worthy of recognition by certificate. The governor can then download and present the certificate.

**Eligibility criteria:** Rotary and Rotaract clubs that have completed projects that made an impact are eligible for recognition.

Award type: Electronic certificate
