# PAUL P. HARRIS - THE FOUNDER OF ROTARY



Paul P. Harris (1868-1947) was the founder of Rotary, the world's first and most international service club. He was born in Racine, Wisconsin, on April 19, 1868. Paul married Jean Thomson Harris (1881-1963). They had no children. He received the bachelor of physical culture and LL.B degrees from the University of Vermont and the LL.D degree from the University of Iowa. He was awarded an honorary Ph.D. from the University of Vermont in 1933.

Paul worked as a newspaper reporter, a business teacher, stock company actor, and a cowboy. In 1896, he went to Chicago to practice law. In 1900 during an after-dinner stroll with a professional friend in a residential Chicago neighborhood, Paul was impressed by the fact that his friend stopped at several stores and shops in the neighborhood and introduced him to various tradesmen in their stores. This reminded Paul of his New England village and it occurred to him: "Why not have a fellowship composed of businessmen from different occupations, without restriction of politics or religion?" He resolved to organize a club that would band together a group of representative business and professional men in friendship and fellowship.

In February 1905, Paul Harris formed the first club with three of his law clients - Silvester Schiele, a coal merchant, Gustavus Loehr, a mining engineer, and Hiram Shorey, a merchant tailor. Because the group's meeting locations rotated from one member's place of business to the next, Harris christened his new club "Rotary."

The second Rotary club was founded in San Francisco in 1908. In August 1910, when there were 16 clubs, the National Association of Rotary Clubs was organized. By 1921, the organization was represented on every continent, and in 1922, they adopted the name Rotary International. Paul Harris' dream, the Rotary Club, has continued to grow and expand over the years. The burgeoning movement in Asia, and the over 220 clubs in Eastern Europe, are extending Paul Harris's ideals of friendship, community service, education, and peace across the world.

# 2020-2021 DISTRICT 6820 GOALS

## GOALS FOR 2020-21 SERVICE & IMPROVED PUBLIC IMAGE WILL INCREASE MEMBERSHIP & FOUNDATION GIVING

1. **Keep all clubs functioning while complying with social distancing requirements with a membership increase in all clubs,**  
The COVID-19 pandemic proposes a challenge to us during the 2020-21 Rotary year. The health and safety of Rotarians are of paramount importance, and in many cases, this will mean no face-to-face club meetings or, at the very least social distancing. In fact, Rotary International has stated, "Governors are strongly encouraged to use virtual meetings for club visits that occur during calendar year 2020." Every effort needs to be made for clubs to meet on a regular basis so that Rotarians will continue to perform some kind of public service. This will keep our members involved in the good things Rotary does in the world. Every club should make a united effort to keep their club functioning and actually have a goal to increase membership during this stressful time.
2. **Every club have or participate in at least one new humanitarian service project**  
Each club needs to have at least one humanitarian project to improve its community. This gets club members more involved in the good things of Rotary. Local service projects can bring the public's attention to Rotary and likely increase club membership.
3. **Have a successful district-wide service project**  
A successful district-wide service project will give unity to our district and, with promotion, will make Rotary more recognizable in our district, not to mention the good it will do in making our district a better place in which to live. Every club will be able to participate in some way.
4. **Publicize Rotary's work in our district and each club's local projects**  
Many of our Rotary projects are kept secret from the public as well as from the district. People ask, "What is Rotary?" Let's tell them! Let's utilize news releases in the local media as well as social media. If people know the good work we do, they will be more inclined to support Rotary and, in many cases, will want to join our ranks and become Rotarians themselves.
5. **Complete our global grant projects with India toilets**  
It is important for us to remember that Rotary is a worldwide organization, and we need to help address needs in other parts of the world. Upon witnessing an entire Indian community with no toilets and discovering that 30% of the world's population defecate outside is enough for District 6820 to take the lead in two projects to provide toilets for schools and homes in India. It's only \$300 to put a toilet in a home and \$7,000 for a school toilet block, which allows girl students to attend school with dignity. Support from individual clubs is strongly encouraged.
6. **Increase contributions to The Rotary Foundation**  
The Rotary Foundation is recognized for the superb way in which they use their funds and the enormous good they do in the world. Our district has been the recipient of funds during times of need as well as receiving our portion of funds for district grants every year. We should step up by making every effort to contribute to The Rotary Foundation at this time of crisis.

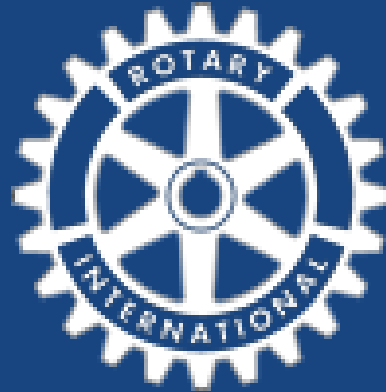
