

Rotary's Guiding Principles

Community Service

Rotary Community Service encourages and fosters the application of the ideal of service to the personal, business and community life of every Rotarian. In carrying out this application of the ideal of service, a variety of activities developed by Rotary clubs have afforded significant opportunities for service by their members.

Community Service is an opportunity for every Rotarian to exemplify "Service Above Self." It is the commitment and social responsibility of every Rotarian and Rotary club to improve the quality of life for those who live in the community and to serve the public interest. (Rotary International Code of Policies 8.040.2)

Object of Rotary

The Object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

FIRST: The development of acquaintance as an opportunity for service;

SECOND: High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying of each Rotarian's occupation as an opportunity to serve society;

THIRD: The application of the ideal of service in each Rotarian's personal, business, and community life;

FOURTH: The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional persons united in the ideal of service.

(Rotary International Constitution Article 4)

The Code of Conduct

The following code of conduct has been adopted for the use of Rotarians:

As a Rotarian, I will:

1. Act with integrity and high ethical standards in my personal and professional life
2. Deal fairly with others and treat them and their occupations with respect
3. Use my professional skills through Rotary to: mentor young people, help those with special needs, and improve people's quality of life in my community and in the world
4. Avoid behaviour that reflects adversely on Rotary or other Rotarians
5. Help maintain a harassment-free environment in Rotary meetings, events, and activities, report any suspected harassment, and help ensure non-retaliation to those individuals that report harassment.

Paul Harris



Paul P Harris was born in Racine, Wisconsin, USA on April 19, and spent his early years in Wallingford, Vermont. He went on to study Law at the University of Iowa, and following his graduation in 1891, spent the next five years seeing

the world. He then went to Chicago to practice law. Today Rotary is well known throughout the world for its dedication to service and international goodwill. This was hardly uppermost in the mind of Paul Harris when he founded the organisation in Chicago in 1905. He envisioned a new kind of club for professionals that could recapture some of the friendly spirit among businessmen that had existed in smaller communities. On Feb 23 1905, he invited three friends to a meeting where they discussed Harris' idea that business leaders should meet periodically to enjoy fellowship and to enlarge their circle of business and professional acquaintances. Among them was a coal merchant, a mining engineer, a merchant tailor and Harris, a lawyer.

The club met weekly and membership was limited to one representative from each business and profession. Though the term Rotary was not used that night, it is commonly regarded as the first Rotary meeting. Paul Harris named the club „Rotary,, because members met in rotation at various places of business. The name met with general approval and club membership grew rapidly.

When Paul Harris became Club President in its third year, he was anxious to extend Rotary to other cities because he was convinced that the Rotary Club could be developed into an important service movement.

Rotary International President

President Gordon R. McNally is a graduate of dental surgery at the University of Dundee, owned and operated his own dental practice in Edinburgh. He was the chair of the East of Scotland branch of the British Paedodontic Society and has held various academic positions. He has also served as a Presbytery elder, chair of Queensferry Parish Congregational Board, and commissioner to the church's general assembly.

A Rotary member since 1984, McNally has been president and vice president of Rotary International in Great Britain and Ireland. He has also served Rotary International as a director and as member or chair of several committees. He is currently an adviser to the 2022 Houston Convention Committee and chair of the Operations Review Committee.

President McNally and his wife, Heather, are Major Donors and Benefactors of The Rotary Foundation. They are also members of the Bequest Society.

When he revealed the 2023-24 presidential theme, *Create Hope in the World*, during the Rotary International Assembly in Orlando, Florida, USA, on 9 January President McNally urged members to promote peace in troubled nations, help those affected by conflict, and maintain the momentum of initiatives begun by past leaders.

"The goal is to restore hope — to help the world heal from destructive conflicts and, in turn, to help us achieve lasting change for ourselves.



The theme was inspired and detailed with a story of hope following the tsunami in southeast Asia when Gordon was given a small conch shell by a survivor who had lost her family, home and livelihood. The efforts of Rotarians had restored her optimism and given her hope.

DISTRICT GOVERNOR

Neil Murray Governor D9910 2023 - 2024



Neil is a member of the Rotary Club of Takapuna. He was raised and educated on Auckland's North Shore. Neil practiced law in Takapuna for 45 years before retiring three years ago from his law firm, Armstrong Murray, where he practiced mostly in property and trusts and advised in business acquisitions and sales. Neil remains involved as trustee or advisor in several charitable, educational, and private trusts outside Rotary, including Age Concern, the North Shore Housing Trust for the disabled and the Marist Alternative Education Trust. He is also a trustee of the Takapuna North Community Trust, responsible to the Devonport Takapuna Local Board, and is a legal advisor at the Takapuna Citizens Advice Bureau, which he has supported since its inception.

Neil joined the Takapuna Rotary Club in 1980 where he served as Club President in 1986-87 and again in 2020-21. However, Neil has been associated with the Club since he was 17 when the Club

sponsored him as a Rotary Exchange Student to District 717 in upstate New York. The Takapuna Rotary Club was the first club established on Auckland's North Shore in 1953. The Club has fathered seven other clubs on the North Shore and over the years has contributed strongly to Rotary's ethic of service to the community. This is seen in the formation of enterprises which still continue, such as Abilities which provides employment for disabled people, and MUNA - Rotary's Model United Nations Assembly.

The Rotary Exchange experience inspired Neil to become a member of the D9910 RYE Committee. He has served on the Committee for over 20 years and chaired it twice for 5 years. Neil and his late wife, Jan, hosted, counselled and mentored many students. All his family members have also been involved in youth exchange. He is passionate about RYE which develops character and teaches language and cultural awareness in young people and which has led him to believe in the RYE mantra of "a year in a life and a life in a year". One of Neil's challenges as Governor will be to reset the RYE programme, "the jewel in Rotary's crown", after three years in recess.

Neil has four adult children, and two grandchildren, of which he is very proud.

Outside of Rotary Neil will be found at cricket. He coached Auckland Age Group sides at the National Championships for 10 years and is a member of the ACA Judicial Committee. Neil is a Life Member and the proud Patron of the Takapuna District Cricket Club, last year New Zealand's champion club side.

PRIP Barry Rassin
Chair 2023 - 2024

Barry Rassin is member of the Rotary Club of East Nassau, New Providence, Bahamas. He served as Rotary International President in 2018-2019 with the theme "Be the Inspiration", and helped to elevate Rotaract during his presidency. In 2023-2024, Barry Rassin will serve as The Rotary Foundation Trustee Chair.

Before becoming RI President, PRIP Rassin served at all levels of Rotary including Club President in 1987-1988, and Governor of District 4040 during 1991-1992. He also made a big mark leading Rotary's relief and recovery efforts after the 2010 earthquake in Haiti, which included 105 separate projects funded by Rotarians. "I had a spreadsheet with 132 pages and every detail of every project," he says. "People look at it and say, 'How do you do this?' But I enjoyed that."

Rassin's leadership abilities served him well in his professional life as a hospital administrator. The first fellow of the American College of Healthcare Executives in the Bahamas, he retired after 37 years as president of Doctors Hospital Health System, where he still serves as an adviser.

Rassin has been a Rotarian since 1980 and received Rotary's highest honour, the [Service Above Self Award](#), for his work. He and his wife, Esther, are Major Donors and Benefactors of The Rotary Foundation. They are also members of the Bequest Society.

CITATION GOALS AND INSTRUCTIONS

The Rotary Citation awards recognize the hard work clubs do throughout the year. Working to achieve the citation goals helps clubs engage their members, stay relevant in their communities, and run more efficiently. A welcoming and engaging club not only fosters a positive experience for its members, but also reflects the values of Rotary. When clubs achieve citation goals, they contribute to the overall health and culture of Rotary for generations to come.

Your Rotary, Rotaract, or Interact club can earn a Rotary Citation for achieving goals that strengthen Rotary and your club. Goals include increasing club membership, developing sustainable service projects, giving to the Rotary Foundation, and building awareness of Rotary in your community.

To achieve a Rotary Club Citation, Rotary club leaders go into Rotary Club Central and select at least 13 out of 26 goals they wish to apply toward citation achievement. This flexibility allows clubs to choose the goals that are most relevant and achievable. In addition, many goals will be self-reported by marking “achieved” in Rotary Club Central.

Club Qualification

District Grants The objective of a Rotary Foundation District Grant is to enable Clubs to support the Rotary Foundation's mission by supporting clubs to carry out a small project which address an immediate need that has been identified in their local community. District Grants are funded by the Rotary Foundation through the District Designated Fund (DDF) allocation and will generally match Club contributions at 100% ("dollar for dollar"). For the 2022/23 Rotary year, District 9910 has available up to NZ\$54,000 (20 x \$2000 grants) for distribution as District Grants. Club Qualification Clubs must be qualified to receive Rotary Foundation District Grants.

Club Qualification Clubs must be qualified to receive Rotary Foundation District Grants. Qualification is required for each Rotary year. Requirements for qualification are:

1. A Club must submit a signed Club Memorandum of Understanding (MOU).
2. A Club must have contributed to the Rotary Foundation Annual Fund at least once over the past 3 years.
3. A Club must have entered their Rotary Foundation goals on www.rotary.org
4. All Rotary International and District dues must be paid up to date.
5. Training:
 - a. A Club representative must have completed the online 'Grant Management Seminar' in the Learning Centre of My Rotary, OR
 - b. The President Elect has attended both PETS and SPETS for the 2023-24 year, OR
 - c. A Club member is an active, participating member of the District Foundation Committee
6. Qualification is required for each Rotary year.

Clubs that qualify for these recognitions receive the right to use the above icons in their webpages, social media pages, newsletters etc. They also receive a certificate that they are encouraged to display.

RNZWCS was established to recognise the need to take a New Zealand wide view of World Community Service and each of the six NZ Districts are represented on the board. RNZWCS is registered with the Charities Commission (CC26860). Of particular importance is the MFAT requirement to have a single New Zealand interface when accessing funds. RNZWCS is recognised by the New Zealand Government as a Non-Government Organisation [NGO]. Clubs seeking funding must work through RNZWCS which maintains a register of potential projects and provide opportunities for clubs to participate in larger world community service projects. Details of the criteria and the procedure for applying for grants and other information can be found on the RNZWCS web site www.rnzwcs.org. RNZWCS also operates a Donations in Kind scheme which advises on needs, provides storage and coordinates the distribution of goods, including emergency response kits, particularly to the Pacific Islands.

Taxation Status - Background

RNZWCS Limited (Rotary New Zealand) has been granted overseas donee status under the Taxation (Tax Administration and Remedial Matters) Act 2011: Overseas donee status Schedule 32 of the Income Tax Act 2007. Charities that apply some or all of their funds outside New Zealand must be approved for charitable donee status by Parliament. These organisations are listed in schedule 32 of the Income Tax Act 2007. Donations to listed organisations entitle individual taxpayers to a tax credit of 33 1/3% of the amount donated up to the level of their taxable income, and companies and Māori authorities to a deduction for donations up to the level of their net income.

ShelterBox

ShelterBox is an international disaster relief charity that provides emergency shelter and lifesaving supplies to families around the world who are affected by disasters. ShelterBox responds to earthquakes, floods, tsunamis, hurricanes, landslides, typhoons and conflict, delivering lifesaving aid to families across the globe at a time when they need it the most.

The ShelterBox solution is to provide a large box, tailored to each type of disaster but typically containing a disaster relief tent for an extended family, blankets, water purification and storage 40 equipment, cooking utensils, a stove, a basic tool kit, a children's activity pack and other essential items. ShelterBox relies entirely on public donations and could not operate without the generosity of Rotarians and people the world over. A ShelterBox can be sponsored for NZ\$1,500 – which takes into account the cost of all materials, packing, storage, transport worldwide and delivery to families in need at a time of disaster by a team of ShelterBox volunteers.

Highly trained ShelterBox Response Team volunteers or SRT's, distribute boxes on the ground, working closely with local government organizations, international aid agencies and Rotary clubs worldwide. Every ShelterBox bears its own unique number so that as a donor you can track your box all the way to its recipient country, via the ShelterBox website.

To date more than 1 million people have been provided with shelter, warmth and dignity following more than 170 disasters, in over 75 countries.

Whilst here, the children and care-giver are looked after by New Zealand families, fostering international learning and understanding in the process.

The Trust now has available approximately \$100,000 for distribution each year and considers applications for grants as soon as received.

Assistance to Rotary clubs is usually limited to 50% of the cost of the project up to a maximum of \$10,000 for each project.

The objects of the trust are to: -

- Assist financially any child Resident in the Pacific Islands who is in need of medical treatment or care in NZ, including fares and related costs.
- Provide medical assistance for children in NZ or elsewhere.
- For medical research (related to children)
- For charitable purposes as defined in the Charitable Trusts Act. To assist financially and support the educational and vocational exchange between people of the Pacific Islands of District 9910 and New Zealand.
- For charitable purposes as defined in the Charitable Trust Act 1957.

The Trustees encourage Clubs to make use of this fund by searching out deserving projects requiring assistance, then making application through the Chairperson.
