2. Clause 9

(line 9)

Delete the words 'Ex Officio Trustees and the Lifetime Trustee.' and insert the word "Trustees"

(line 10)

Immediately after the word, re-appointment, add:"Should a Term Trustee retire during his/her appointed three year
term of office, The Trustees will appoint a replacement Trustee
for the remainder of that term."

3. Clause 14

(line 4)

Delete the word four (4) and replace with "three (3) persons present" Delete the final sentence beginning, The Chairman --------- and replace with "The Chairman of Trustees will be appointed annually by the Trustees when re-appointing or replacing a retiring Term Trustee for the forthcoming Rotary year. The Chairman shall have a casting vote.

## PROPOSED ADDITIONS TO THE DEED OF TRUST

- The Trustees will annually appoint a suitably qualified Secretary and Treasurer.
- 5. The Trustees shall arrange for preparation of annual financial statements for the trust year running from 1st July in each year to the 30th June the following year and a suitably qualified auditor shall be appointed to audit the accounts.
- 6. The Secretary or any Trustee will give a minimum of ten days notice of meetings to all Trustees unless for convenience Trustees agree to accept an earlier meeting date.

- Trustees may make changes to the Deed of Trust providing:-
  - (a) Such changes are beneficial to the Trust
  - (b) Such changes do not detract from the original main purpose of the trust as stated in clause 3 of the said deed.
  - (c) The changes are agreed to by at least 75% of Trustees.
  - (d) The changes do not affect the IRD taxation status of the Trust.
- 8. At least one general meeting of Trustees will be held each year at which time financial statements will be presented and the retiring Term Trustee will be re-appointed or replaced.
- 9. Payment of all Grants to be approved by the Trustees
- 10. Any Trustee who is or may be in any other capacity whatever interested or concerned directly or indirectly in any property or undertaking in which the Trust is or may be in any way concerned or involved shall disclose the nature and extent of that Trustees, interest to the other Trustees, and shall not take any part whatever in any deliberations of the Trustees concerning any matter in which that Trustee is or may be interested other than as a Trustee of the Trust.
