#### Congratulations to New Directors On District Board...

On Saturday, January 16<sup>th</sup>, the District Nominating Committee, chaired by PDG Kerry Nix, met to select individuals to fill the two open spots on the District Board of Directors.

Please help me congratulate Bob Chavey of the Rotary Club of Newfoundland and PDG Carol Hemphill of the Rotary Club of North Pocono for both their willingness to serve and for their selection. Bob will be serving a 1-year term, and Carol will be serving a 2 -year term.

At the same meeting, the Nominating Committee appointed DG Barbara Belon to serve as the district's Vice Governor for the 2016-17 Rotary year. As a side note, the Vice Governor position was established to provide for smooth succession planning within the district, in case the sitting governor becomes unable to continue serving.

#### District 7410 Supports Another District's Global Grant ...

District 7410 pulls off some amazing projects in our communities of Northeastern Pennsylvania.

That's not news to you, but what is news is when our District provides assistance to another District's global grant. This spring, our district is providing \$4,000 in financial support for District 7210's global grant project to Haiti. Our \$4,000 actually turns into \$8,000 since the Foundation's World Fund matches our donation dollar-for-dollar. The description of this much-needed, and large-impact global project follows.

Together with their co-applicant, the Cap Haitien Rotary Club ("CHRC"), the **Liberty Rotary Club** ("LRC") of District 7210 is proposing a project to purchase and distribute 1,000 two-bucket water filtration systems to 1,000 families in the Cap Haitien region of Haiti. This project is anticipated to provide clean and potable water to over 5,000 residents. The twobucket systems are manufactured by Gift of Water, a non-profit organization which only has one paid employee (www.giftofwater.org).

The budget for this project is \$105,000, of which at least \$30,000 will come from DDF (with 100% matching funds from the Foundation), with the balance (subject to the 50% matching funds from the Foundation) being raised by the LRC and the CHRC.

The families will be chosen by a water committee which is being created and which will be comprised of three members of the CHRC, one representative from Notre Dame D'Altagrace (a parish in Cap Haitien which serves that community and which was involved in a prior District Grant project of the LRC involving the purchase and distribution of 100 of the two-bucket water filtration systems to 100 families in Cap Haitien) and one member of the Cap Haitien community. The water committee will also hire, cause to be trained and pay up to five technicians, who will meet with the 1,000 families on a biweekly basis to test the water, obtain supplies for the families, answer questions, and prepare and provide monthly reports to the water committee (which reports will be shared with the CHRC and the LRC).

District 7410's modest donation from our Global Grant funds will help District 7210 reach their financial target for the project. By extension, our entire district membership can feel good about the fact that, even in a small way, we have played a major role in providing clean water for thousands of Haitiens.

That's the power of our Rotary network in action!

# District 7410 Rotarians: Here's How Our RI Director Will Be Chosen at Conference

At the 2017 RI Convention in Atlanta, USA, a director will be elected from among Rotarians in our Zone 32. RI Bylaws, section 12.020, provides that RI directors-nominee be selected by a zone nominating committee, comprising one member from each district in the zone. You are being advised of your responsibility for selecting District 7410's member of the **2016-17 RI Director Nominating Committee**.

Previously, all clubs in District 7410 were sent the guidelines for nomination. To date, two qualified candidates have been nominated by their respective clubs. As governor, I have asked each of them to write a brief statement of why they feel qualified to serve on our behalf. Those statements, along with the candidate's photo appear below.

Since the **voting** to select our district's representative will occur on **April 30<sup>th</sup> at our District Conference**, the following instructions are pertinent for your club's participation:

• Voting: The election vote is scheduled for 3:00 pm on Saturday, April 30<sup>th</sup>. Your club's delegate MUST BE PRESENT to present your club's vote(s). The club delegate DOES NOT HAVE TO BE AN AT-TENDEE at the district conference, but can come to the venue just to present the club's authorized vote.

• **Voting process**: Your club's vote must be made **in writing** and **signed** by the club president and secretary. That authorized vote is **handed in** at the 3:00 District Voting Session.

• **Authorized votes**: The size of your club determines the number of votes given to your club. The following is excerpted from the RI Manual of Procedures:

Each club shall be entitled to at least one vote. Any club with a membership of more than 25 shall be entitled to one additional vote for each additional 25, or major fraction thereof, of its members. Such membership shall be determined by the number of members in the club as of the date of the most recent semiannual payment, preceding the date on which the vote is to be held. However, any club whose membership in RI has been suspended by the board shall not be entitled to participate in the voting.

Thank you in advance, for taking this election seriously and sending your club's representative to the April 30th voting venue. -- DG Barbara

## **Rep. Karen Boback Honored by Rotary International**

State Representative Karen Boback was recently presented with her second Rotary Paul Harris Fellowship. Past Rotary District Governor Paul Muczynski presented the fellowship to Representative Boback noting her continued support of the welfare of the citizens of Pennsylvania.

In addition, Representative Boback was able to get a House Resolution passed recognizing Rotary International's efforts to eradicate Polio from the world through a comprehensive vaccination program, making good on a promise it made in 1985.

When the campaign began, there were more than 1,000 new cases of Polio every day. As of December 31, 2015, there were just 70 cases in two countries. The World Health Organization (WHO) predicts the last case of the wild Polio Virus infection will occur this year. When Polio is eradicated it will be the second disease eradicated, Small Pox being the first.

# Looking at Fundraisers and Rotary's Policies

It has come to the attention of Rotary International that some Rotary clubs are sponsoring or hosting gun and knife shows, shooting tournaments and hunts **and are using Rotary's trademarks on ma**terials for these events. As a reminder, the RI Board has set forth guidelines for use of the Rotary Marks by Rotary clubs for sponsorship and cooperative relationship purposes, and this policy prohibits clubs from accepting relationships that support the use of harmful products, including weapons and other armaments; see the relevant *Rotary Code of Policies* Section below.

RI Board would not take kindly to learning that Rotary clubs have ignored this policy and are sponsoring or hosting gun and knife shows or that the clubs are hosting or sponsoring shooting tournaments and hunts. If your club has already started planning for such an event, sponsoring or hosting gun/knife shows, shooting tournaments and/or hunts, that you cease such activity immediately

From the Rotary Code of Policies:

11.020.6. <u>Guidelines for Use of Rotary</u> <u>Marks by Rotary Clubs, Rotary Districts</u> <u>and Other Rotary Entities for Sponsorship</u> <u>and Cooperative Relationship Purposes</u>

 a) 20. No Rotary club(s), Rotary district(s) or other Rotary Entity shall accept a sponsorship or a cooperative relationship that

a. Conflicts with Rotary's ethical and humanitarian values

b. Undermines internationally recognized standards for human rights

c. Supports the use of addictive or harmful products and activities including but not limited to alcohol (when inappropriate in a specific cultural context), tobacco,



gambling, and weapons or other armaments

d. Promotes a particular political or

religious viewpoint

e. Involves abortion

f. Unfairly discriminates based on race, ethnicity, gender, language, religion, political or other opinion, national or social origin, property, or birth or other status

g. Weakens the autonomy, independence, reputation, or financial integrity of Rotary International, The Rotary Foundation, or the specific Rotary club, district or other Rotary entity

h. Involves any subject matter which is not in accord with the Object of Rotary

It is also important to know that the U.S. Rotary club and district liability insurance program *does not provide coverage* to its insured for activities that are in conflict with the *Rotary Code of Policies*.

# A Tall but True Tale of Tunkhannock's 10,000 Books

Once upon a time, there was a Tunkhannock Rotarian named Lou Jasikoff. who hosts an internet talk radio show (Jasikoff & Friends) on Twigs Café Radio and has founded and published several Independent Gazette newspapers. In late November, Lou interviewed Dean Debra Pellegrino of the University of Scranton's Panuska College of Professional Studies (PCPS) and two of her colleagues regarding illiteracy issues in the region and nationwide. During the discussion, Dean Pellegrino briefly described the "Blessing of the Books" Program of the PCPS, where children's books are collected and distributed to organizations and children's programs to promote literacy.

#### Club's Up to Challenge

After the radio interview, Lou brought this challenge to the next Tunkhannock Rotary Club meeting and before Lou could get back to his seat, the club had voted to buy \$100 worth of children's books from the Tunkhannock Public Library (TPL) book store. So on Dec 3, the Club presented Lou with 200 books for this program.

But the Rotary Club's involvement did not stop there, Terry Furman, Chair of the Club's Literacy Committee and a teacher/trainer for H.A.N.D.S. of Wyoming County, called upon Tunkhannock Area School District (TASD) Superintendent Frank Galicki to promote this program in the four elementary schools

# Looking Back at the Scourge of Polio

Our Rotary resolution each year remains the same, to end polio in the world. That resolve will continue until there is not one more case of polio on our planet.

The World Health Organization defines Poliomyelitis, commonly called polio as a highly infectious viral disease, mostly affecting young children. The virus is transmitted person-to-person or by contaminated water or food. The virus multiplies in the intestine, gets into the nervous system and causes paralysis. The first symptoms do not appear alarming at first with fever, fatigue, headache, stiff neck and pain in the limbs. When those symptoms grow worse, the patient is often left paralyzed. There is no cure for this disease only prevention of it through immunization through the Salk vaccine, a little pill that slips under the tongue.

Fifty years ago polio was considered one of the most frightening public health problems in the world.

In 1952 the United States epidemic was the worst outbreak in our history with 58,000 cases reported; 3,145 people died and 21,269 were left with disabling paralysis. The most famous victim of polio was President Franklin D. Roosevelt, who started the March of Dimes Foundation to develop a vaccine. First called the Mothers March of Dimes, women were encouraged to go door-to-door to collect dimes. I remember my own mother going to her neighbors and school drives where children placed dimes in large cards, all to end polio. The drive was really called the National Foundation for Infantile Paralysis, an organization which funded research for a vaccine.

Jonas Salk was a physician who gathered a skilled research team and for seven years worked diligently on development of the vaccine. News of the success of the vaccine became public on April 12, 1955, Salk was hailed as a miracle worker.

Countries around the globe started campaigns using the Salk

vaccine. Salk considered public health as a moral commitment. He was not interested in personal financial gain and would issue no patent, saying, "Could you patent the sun?" His focus was on a mandatory vaccination for every person. Rotary is still working on that in the remaining countries where polio is still a threat.

#### Great New from Nigeria

On September 25, 2015, the World Health Organization (WHO) announced that Nigeria is polio free and has been removed from the list of countries where polio is endemic. To get this status, Nigeria had to prove it had been 14 months free of any new cases of polio. That leaves only two countries, Afghanistan and Pakistan where the transmission of the virus has not been stopped. This accomplishment by Nigeria came about through large national and international financial commitment, and the dedication of thousands of professional volunteers who put together new strategies to reach children who had not previously been immunized.

With Nigeria now polio-free, Rotary's focus will be placed on vulnerable children from Afghanistan and Pakistan, while still continuing to immunize the children in polio-free countries.

# Is Your Interact Club Eligible for Presidential Citation?

Your Interact club is making a positive difference in your school and community. Make sure your members get the recognition they deserve by earning a Presidential Citation for your club.

Your sponsor Rotary club president must verify that your club has qualified for the citation by **15 April 2016**. He or she will receive instructions from RI for reporting the names of qualifying Interact clubs by 1 March.

#### **Charitable Rollover Returns**

The law that allows you to make a tax-free gift from your individual retirement account (IRA) directly to charity has been reinstated and made permanent! Known as the IRA charitable rollover, this law no longer has an expiration date so you are free to make annual gifts to The Rotary Foundation from your IRA this year and well into the future

The recently reinstated law allows individuals 70½ and older the ability to transfer up to \$100,000 from their individual retirement accounts directly to a qualified charitable organization without being subject to federal income taxes on the distribution.

Are you eligible?

You must be at least age  $70\frac{1}{2}$  or older at the time of the gift.

You may transfer up to \$100,000 directly from your IRA. This opportunity applies only to IRAs and not other types of retirement plans.

You may transfer the funds outright to one or more qualified charities.

The legislation does not permit direct transfers to charitable trusts, donor advised funds, charitable gift annuities or supporting organizations.

An IRA charitable rollover gift can satisfy all or part of your minimum distribution requirement, and is a great way to meet your Paul Harris Society goal through a gift to the Annual Fund!

#### Mandatory activities

Your club status must be active. Ask your sponsor Rotary club president to confirm your status in the Listing of Club-Sponsored Organizations report in <u>Rotary Club Central</u>.

Work with your sponsor Rotary club on your activities throughout the year.

#### Additional activities

Complete at least **five** of the following activities between 1 July 2015 and 1 April 2016:

Participate in at least one activity that promotes international understanding.

Introduce your members to other Rotary opportunities for young leaders, such as <u>RYLA</u> or <u>Rotary Youth Exchange</u>.

Participate in an event to build awareness of, or to raise funds for, the <u>polio eradication campaign</u>.

Submit a video for the Interact Video Contest.

Participate in a school or community service project or fundraiser that supports one of <u>Rotary's areas of focus</u>.

Collaborate with one of <u>Rotary's service partners</u>, such as YSA (Youth Service America).

Participate in a career day or mentoring activity.

Connect graduating Interactors with a university- or community-based Rotaract club so they can maintain their Rotary connection. Search for Rotaract clubs in <u>Club Finder</u>.

Committee said recently, "With a fully funded program and global commitment to ending this disease, we have the opportunity to interrupt transmission of the wild poliovirus in Pakistan and Afghanistan in 2016 and opening the door for certification of a global eradication in 2019.With Rotary members' continued support, we will soon see our dream of a polio-free world realized."

Every week when the Rotary Club of the Abingtons meets, the campaign for the eradication of polio continues. We have a container where loose change can be dropped, a reminder of the March of Dimes. As we partner with Rotary Clubs nationally and then internationally we are able to come up with a sizeable chunk of change. To that the Gates Foundation adds two dollars to every one of our dollars, increasing the original loose change to grow to the millions needed for immunization for every person in the world.
