

#### Public Image Corner Hunger doesn't take a holiday!

Here's an idea for a timely project that will fill an immediate need in your community and get your club noticed as a group of dedicated people who tackle real issues in real time. How about a holiday food drive for your local food pantry?

Hunger doesn't take a holiday. Food pantries are low on supplies due to current demand, and the holidays are coming up with many families in need counting on food pantries for their Thanksgiving meal. And winter will soon be upon us with many families struggling with decisions involving food vs. fuel or food vs. medications.

You can make your project small or limited by doing a food drive just within your club. Or you can take your efforts public and hold a food drive in your community.

A quick look through the weekly circulars In the Sunday papers will give you plenty of low cost ideas for where to purchase the food you wish to donate if you decide to keep it at the club level. Many grocery stores and drug stores have "buy one, get one" specials, and there are always the big box stores where multiple units can be purchased at a reduced cost.

If you decide to take the project out to your community, consult with a local food store or drug store to see if they will let you use their location as a donation drop point. Set up a table on a Saturday and ask folks to help you help others.

Big or small. Your project will help your Rotary Club be a visible force for good in your community.

ENACTMENTS seek to change RI's constitutional documents and RESOLUTIONS express an opinion or make a recommendation to the RI Board.


All proposed legislation must be approved by the District and then forwarded to RI no later than December 31<sup>st</sup>, 2014.



The Auxiliary provides fundraising and support services to the Bushkill Volunteer Fire Company. The mobile kitchen is used to provide food and support for lengthy fire emergencies and other civil emergencies such as hurricanes and storms.

#### Peace Camp 2014

The Tunkhannock Rotary Club received a District Grant for an inaugural **Peace Camp** that was held July 6-10 at St. Peter's Episcopal Church facilities in Tunkhannock. The Camp was open to kindergarten to 5<sup>th</sup> graders and was held in cooperation with the Interfaith Peace and Justice Commission in Wilkes Barre.

This first year of Peace Camp brought delights, challenges, insight, and joyful peace throughout the week. Each day, the children named something they were grateful for before breakfast and lunch. They could not be grateful for the same thing the person in front of them was grateful for. Each idea and offer of thanks was different. Part of each day was learning peace-making skills by directed role play. One child would pretend to do something, another (or more) would try to entice the child to do something they should not do, and the child had to use language to resist.

The Camp director pointed out that each child was able to name a particular person who had either bullied them individually or had bullied another child. Even when this bully was reported to an adult, no response came from the adult. He said he had never heard this before. Children might say they had been bullied, but did not name, or were unable to directly name, the perpetrator.

A professional clown talked about anger (Silly Sally was a highlight!). Other speakers included Phil Swank who spoke about the local environment, especially the Iroquois trail near the church. Daralynn Carr talked about juvenile detention and probation, with complete police gear attached.

The children enjoyed working in the garden, and walking on a special mowed path throughout the week. Another highlight was using sidewalk chalk to write words, messages, and pictures of Peace Camp.

The food was very good! Well prepared, well liked, and all were full! The children and adults ate fresh fruit, sugarfree cereal, drinks and snacks, salads, wraps, veggie burgers, and pita pockets filled

Rotarian Rev. Lou Divis, Rector of St. Peter's Episcopal Church, thanked the Tunkhannock Rotary for sponsoring this year's inaugural Peace Camp. She indicated that the program was successful and will be repeated by St. Peter's next year, using lessons learned from this year's Camp.

**Drug Take Back Day** (coordinated by the DEA) occurred on Saturday Sept 27 from 10 AM to 2 PM at CVS and Lech's Pharmacies in Tunkhannock. Although the Wyoming County District Attorney's office runs this program, and is responsible for the collection, security and proper disposal of the drugs, the Tunkhannock Rotary Club helped the DA's office educate the public about this important program to clean old, expired or no longer needed medicines out of people's medicine cabinets. Most abused prescription drugs come from family and friends.

In cooperation with the DA's office, a committee led by Matt Pompey took responsibility for all public relations and advertisement for this program, including distribution of posters to local businesses to advertise the event, public service announcements that aired over 250 times on 10 radio stations, newspaper articles and ads highlighting the dangers of these unneeded medications, especially for the young, radio interviews on the program and communications with civic organizations, Tyler Memorial Hospital administrators and church clergy who alerted their membership at meetings, from the pulpit and in their newsletters.

Sept.'s Drug Take Back Day resulted in the collection of 162.5 pounds of drugs from people's medicine cabinets, **significantly more drugs than ever before.** This is one of the largest county Take Backs' in PA. Many people said they never knew this program existed and were thankful for all the information the Club provided prior to Drug Take Back Day. #### Note from Our Exchange Student Jason Linden

My first month (and a half) in Mexico has been going pretty smoothly. Honestly, everything is easier than I expected it to be and I've had very few difficulties. With that said, the language barrier is still very large and very real. I really didn't know much Spanish at all when I got off the plane, and now I'm good enough to communicate on a basic level of how I feel, what I'm doing, where I'm from, how I spent my weekend, and where I need to go.

One of the biggest challenges for me was communicating to my family things like where I wanted to go or what I wanted to do, and then getting there. It was easy in the US because I had my own car, internet on my phone, and I could drive where ever I needed to and find my way by myself or call somebody for help if I ever became lost. Here, that's much different. My Mexican phone only calls and texts- barely. I'm considering buying something more reliable. Additionally, I obviously can't drive here, so I had to learn to take the bus. This was complicated at first, because while there is a reliable website with all the bus routes in the city, I was limited to taking the bus routes my family showed me because I wasn't familiar with the stops and I didn't know when to get off or how to ask. However now, my Spanish has improved to a point where I can ask the drivers where they're headed, ask strangers where the bus stops are, and ask passengers if they can help me find where I need to get off. Additionally, I've learned how to explain to a taxi driver where my house is, in case worst comes to worst and I should find myself actually lost.

So as far as transportation goes, my family now trusts me to spend time with friends from school and from the RYE here in Guadalajara and find my way home when I'm done. That's making everything more enjoyable- before I would come home every day right after school, and on the weekends, only do what my family was doing. Now, I'm able to spend time with friends and of course, spend time with my family too.

With everything said, I've really enjoyed the first month or so of my time here in the Mexico and am eagerly awaiting more. Upcoming, not this weekend but the next, I will meet all the exchange students from my district in Puerto Vallarta for a 4day weekend. Beyond that, I'm not really sure what else is upcoming, but certainly lots of fun, plenty of awkward moments where I really wish I knew the language better, and studying of course. I also have blog (http:// а jasonexchange2014.tumblr.com/ ) where you can feel free to check up on some other in's and out's of my life here. Admittedly, an update there is overdue, I'll try to get on that this week to keep everything current.






