Worldwide, 836 million people live in extreme poverty, according to the United Nations.

Rotarians worldwide are committed to reducing poverty by using their skills in projects that provide vocational training and that strengthen local entrepreneurs and community leaders, particularly women, in impoverished communities. Here are just a few of examples, from <u>Rotary Showcase</u>, of members taking action:

• The <u>Rotary Club of Islamabad Mid Town</u>, in Pakistan, established a vocational center to provide training for orphan girls with courses such as sewing, flower making, glass painting, and beautician skills. Successful students also receive help selling their work to earn an income.

• The <u>Rotary Club of Bislig</u>, in Surigao del Sur, Philippines, trained unemployed parents to bake and decorate cakes and cure ham to help them to support their families.

• The <u>Rotary Club of Dhaka North West</u> in Bangladesh built a computer learning center, starting with a single computer in 2002, which has provided training to more than 1,000 students. Many of them have found jobs as a result.

Good Boards Mean Good Clubs

It is my belief that we neglect to think of our clubs and district boards as the governing bodies of our clubs and district. We should consider our board of directors as the re-



sponsible body for our clubs/district, not only for our program and day-to-day operations, but also as the group of people who ensure we adhere to the rules, guidelines and policies of Rotary and our bylaws. With this in mind, consider the Ten Basic Responsibilities of Nonprofit Boards (adapted to Rotary) below as a guide for a good board and a good club:

- 1. Determine mission and purpose. It is the board's responsibility to create and review a statement of mission and purpose that articulates Rotary's goals, means, and primary constituents served.
- 2. Ensure the appropriate people serve in club positions. Boards must reach consensus on the responsibilities of all committee chairs and team leadership, as well as undertake a careful search to find the most qualified Rotarians for these positions.
- 3. Support and evaluate the chairs/leadership. The board should ensure that all committee chairs and team leadership have the moral and professional support they need to further the goals of the club/district/ Rotary.
- 4. Ensure effective planning. Boards must actively participate in an overall planning process and assist in implementing and monitoring the plan's goals.

5. Monitor and strengthen programs and

services. The board's responsibility is to determine which programs are consistent

with Rotary's mission and monitor their

- 6. Ensure adequate financial resources. One of the board's foremost responsibilities is to secure adequate resources for the club/ district to fulfill its mission.
 - 7. Protect assets and provide proper financial oversight. The board must assist in developing the annual budget and ensuring that proper financial controls are in place.
 - Build a competent board. All boards have a respon-8. sibility to articulate prerequisites for candidates, orient new members, and periodically and comprehensively evaluate their own performance.
 - 9. Ensure legal and ethical integrity. The board is ultimately responsible for adherence to legal standards and ethical norms, as well as Rotary's policies and procedures.
 - 10. Enhance the organization's public standing. The board should clearly articulate Rotary's mission, accomplishments, and goals to the public and garner support from the community.

Finally, it is your club's board responsibility to maintain a solid record of your actions through maintaining board meeting minutes and club financial records (RI requires this). These help in planning, creating a history and documenting actions. It is our responsibility as leaders of our clubs and district to ensure that we do the right things to adhere to Rotary's standards, to maintain your club's good

5 Talking Points to Promote Polio Fundraising

Afghanistan and Pakistan are the only remaining countries where the transmission of the wild poliovirus has never been stopped. So if we are so close to eradicating polio, why do we still need \$1.5 billion to finish the job?



As a club or district leader, you may have heard some version of this question from members of your club or community. Given Rotary's status as one of the largest private funders of the polio eradication program, our organization's continued leadership is imperative in these final stages. Below are five talking points to use in explaining to members of your club and community why fundraising and advocacy are as important now as they've ever been.

1. **REACHING EVERY CHILD** To end polio, we need to focus our efforts on reaching every last child in Afghanistan and Pakistan, the only remaining countries where transmission of the wild poliovirus has never been stopped. Both countries require the support of the global community to immunize children who have consistently been missed, and to conduct high-quality immunization campaigns. The biggest expense in a vaccination campaign is not the vaccine but its distribution, including transportation and staffing arrangements.

2. **PROTECTING OUR GAINS** At the same time, we must continue to keep all other countries polio-free, including up to 60 that remain at high risk either due to conflict, population migration, weak health systems, or other conditions. In August, Nigeria reported two cases of wild poliovirus, the first cases detected since July 2014, and a sober-

ing reminder that countries need to remain vigilant. A rapid response plan has been put into place to counter the outbreak.

3. MAINTAINING SURVEILLANCE Stepped-up surveillance is vital to ensure that the virus is truly gone from other parts of the world. This means both checking every report of acute flaccid paralysis (the sudden onset of floppy arms and legs) and testing water for the poliovirus. Only one in 200 cases of polio results in paralysis, meaning that for every child with signs of paralysis, a couple of hundred are carrying the disease and may not exhibit symptoms. Because the poliovirus is most easily detected and spread through stool, researchers take samples from sewage systems or from rivers and open gutters in places lacking sewage systems. Rotary and its partners have developed a network of 145 laboratories worldwide that can identify the disease. Detection activities will intensify this year with additional medical officers and environmental surveillance sites.

4. ACHIEVING CERTIFICATION Even after the final case of polio is recorded, it will take three years to ensure that it is indeed the last case. So even if the last case is seen this year, these programs will continue to need funding and volunteers until 2019, and that carries a price tag of \$1.5 billion.

5. **PREVENTING A COMEBACK** Until we ensure eradication, the risk of resurgence remains. A global resurgence of the disease could bring up to 200,000 new cases a year within 10 years.

The Rotary Foundation—Charitable IRA Gifts

For those age 70½ and older, it is now possible to make tax-free charitable gifts directly from Individual Retirement Accounts (IRAs). This giving option had been available at times in the past and was made permanent in December 2015.

If you have a traditional IRA, you can now make gifts directly to The Rotary Foundation using funds that might otherwise be taxed when withdrawn. You may choose to make charitable gifts directly from an IRA up to a total of \$100,000 per person, per year.

By giving directly from your IRA, you also won't increase your adjusted gross income or possibly subject your Social Security to a higher level of taxation.

Another advantage: Your gift will count toward your Required Minimum Distribution and you can avoid taxes on income while you help Rotary improve communities around the world.

Nigeria Reclassified as Polio Endemic

Nigeria reported three cases of wild poliovirus in the northeastern state of Borno in August of this year. Following the World Health Organization's confirmation of these cases, the country returned to the list of polio-endemic countries. The other polio-endemic countries are Afghanistan and Pakistan.

These are the first cases detected in the country since July 2014, and while this news is disappointing for all Rotary members, we are confident that Nigeria can defeat polio. Rotary provided \$500,000 to assist immediately with the outbreak response, and an emergency response plan has been put into action in coordination with our partners. Large-scale vaccination campaigns are ongoing across five countries in the Lake Chad basin to counter the outbreak.

Despite these new cases, there has been significant progress toward ending polio in Nigeria, the rest of the African continent, and globally.

As recently as 2012, Nigeria accounted for more than half of all polio cases in the world; however, thanks to quality



vaccination campaigns and surveillance, as well as political commitment, the country has made significant progress. Furthermore, the new cases were detected due to ongoing efforts to strengthen surveillance, especially in insecure areas.

We have proven strategies to stop new

outbreaks quickly, even in insecure regions or areas made vulnerable by conflict, such as South Sudan and Syria. These strategies will also overcome the outbreak in Nigeria.

Rotary is committed to the eradication of polio, and we will continue to support our members, particularly those in Nigeria who have worked so hard to help the country end polio. With your help, we can ensure that there is no remaining home for the virus.


and continue to keep the club updated on their projects throughout the year.


