THE ROTARY FOUNDATION—GIVE TO GET

Happy New Year to all of you! Hopefully, we have all enjoyed the holidays. We have put away the decorations, turned off the lights on the bushes outside our houses, and realized that a decorated house looks great, but so does a stripped down house. If you are like me, you are still eating the treats you received as gifts – trying not to eat them too quickly.

Many of us now turn our attention to taxes. My first task is to prepare a list of my charitable contributions for the deduction on my return. Somehow this makes me more willing to calculate the income and the taxes due. We complain about paying taxes, but most of us are fortunate that we have enough income on which to pay taxes. Remember that all of your donations to the Rotary Foundation, whether to the Annual Fund or for Polio Plus, are fully tax deductible.

Matching Gifts by Employers

We do not often remind members to consider whether their employers have a matching gift program. But don't forget that gifts to The Rotary Foundation qualify for those matching gifts from your employer. Many insurance companies and other businesses that have independent contractors or franchisees also will match your contribution or give to the charity of your choice. Please double the value of your gift whenever possible.

Giving by Clubs and Rotarians to Date

As we turn the corner into this new year, and the last half of the Rotary year, it is time to assess our progress in building our gifts to The Rotary Foundation. You may have noticed that each month Connie includes a kind of thermometer or measurement scale to mark our progress towards 100% participation of members and \$161,000 goal for the Annual Fund. This month, as of January 6, 407 of our 1377 members have contributed to the Annual Fund. They have given a total of \$74,986. This is a great number. Thanks to all who have contributed.

As I reviewed club giving, I noticed a huge discrepancy in the giving by various clubs. I pay more attention to how many persons in a club give than to the total amount of the giving. In six clubs, NO members have given anything to the Annual Fund yet. However, on the other hand, **every member of the Birch Run Club** has already given something. **Bad Axe** shows contributions by 44 of 47 members, **Cass City** shows 24 of 30 members have given, **Oscoda** shows 13 of 19 have donated, and 19 of 22 members of **Saginaw Sunrise** have contributed. Congratulations and thank you to these clubs!

Of course, total dollar giving also is important. **Frankenmuth, Saginaw,** and **Cass City** lead in the total number of dollars contributed thus far. Thank you too for your generosity.

Estate Gifts to the Foundation

Perhaps this is a good time to also remind you to make a gift from your estate to The Rotary Foundation – SHARE. Many of us review our estate plans as we prepare our tax returns. If you do, think about giving at least \$1,000 from a life insurance policy or your retirement fund to The Rotary Foundation Endowment – SHARE. (The SHARE part ensures that our district will share the earnings on your gift in perpetuity.) Forty-seven (47) individuals have notified Rotary that they have included the Foundation in their estate plans, to the benefit of this district. I am urging more Rotarians to follow suit. Could we have 100 Rotarians who have designated the Foundation to receive some amount by the end of this Rotary year?

Programs for your Clubs

If your club needs a speaker about the Foundation, please do not hesitate to ask Rod Bieber or me to attend a club meeting. We have spoken to many clubs already this year, but are available for more invitations. As we move into the spring, we will also be offering speakers about our District and Global Grant programs. Remember that, to qualify for a District Grant, your club has to contribute to the Rotary Foundation Annual Fund. You have to give to get!!

Another Year, Another Step Closer

Another year, another step closer to a polio free world. Fewer cases in fewer places than ever before.

When we look back on 2015, it may well be seen as the year the tide irreversibly turned on polio. Wild poliovirus is more geographically constrained than it has been at any point in recorded history. As of 30 December 2015, 70 wild poliovirus cases have been reported from the only two remaining polio endemic countries, Pakistan and Afghanistan, compared to the 341 cases found in nine countries during the same period in 2014.

From Nigeria being removed from the list of polio endemic countries to the declaration of wild poliovirus type 2 (WPV2) eradication to the closure of several outbreaks, progress against polio has accelerated in its remaining strongholds. We are rapidly closing in on the finishing line.

The Northern Bay & Arenac Rotary Club of Pinconning & Standish recently announced that the Northwoods Wholesale Outlet of Pinconning has agreed to be the sponsor for the first Saginaw Bay Nature Festival, which will take place in April 2016.

The Pinconning Linwood Chamber of Commerce will sponsor marketing and logistical activities related to the festival. Sponsorships for individual components of the festival will be as follows:

- Student nature art competition The Rotary Club of Bay City
- Student Conservation Project competition Chemical Bank
- Birding Derby Bittersweet Quilt Shop
- Lecture series on topics related to the Saginaw Bay Pinconning Rotarians

In addition to programs in local schools, there will be a series of presentations during the month of April on topics such as wildlife photography, landscaping with native plants, invasive species, the Saginaw Bay fishery, bird migration, and the Ojibway language.

On January 7, 2016, the Rotary Club met at Standish-Sterling Central High School to hear a presentation by the Director of the Environmental Science Institute (ESI) at Saginaw Valley State University, David Karpovich, on the focus of the Institute, and the work it is doing to coordinate a Conservation Project Competition as part of the Rotary Club's 2016 Saginaw Bay Nature Festival.

The Saginaw River watershed is the largest in Michigan, covering about 8,500 square miles. Saginaw Bay covers over 1,100 square miles. ESI staff study a variety of conditions which contribute to the degradation of the bay, and they are often able to propose conservation actions to help improve the local environment.

ESI staff is working with students at both Standish-Sterling and Pinconning High Schools to design a conservation project. Examples of possible projects include: invasive plant removal on municipal property or park followed by replanting of native species; stabilization of a river or ditch bank to prevent erosion; development of an access point to a river for canoes/kayaks, hiking trails, swimming, boating, etc; development of a platform for viewing birds or wildlife or a fishing platform; identification of storm drains susceptible to contamination and development of a proposal to prevent dumping of harmful contaminants or erosion of soil. These were offered simply as examples. The winning proposal will be referred to one of the area's grant funders for possible implementation.
