## TEAM MEMBER APPLICANT'S CERTIFICATION

2. I understand that I will be responsible for my airfare to and from Taipei.
3. I understand that I will be responsible for obtaining visa and/or other travel documents, if required, from the Consulate of Taiwan.
4. I understand that I will be responsible for medical, travel and all other insurance coverage.
5. I undertake to host, or arrange for the hosting, of a Rotarian and his/her companion from Taiwan when they visit District 7230 in May 2020.
6. I have read and understood the Friendship Exchange guidelines of Rotary International, <https://www.rotary.org/en/our-programs/friendship-exchange>, and the Hosting Guidelines of R.I. Dist. 7230, and agree to abide by them. I further agree that I will be bound by Rotary International's applicable policies, bylaws, and regulations, by whatever name called.
7. During the exchange, I agree to
  - a. accept the decisions of the team leader at all times;
  - b. remain with the Team throughout the program, except
    - i. during those periods when individual activities are specifically provided, and/or
    - ii. expressly excused by the team leader; and
    - iii. inform the team leader of my whereabouts at all times;
  - c. maintain standards of behavior and deportment during my travels with the Team that will reflect credit on Rotary, my district, and my country;
  - d. refrain from engaging in dangerous or illegal activities;
  - e. have sufficient funds to meet my personal and incidental expenses while abroad.
8. I understand that I may, if I so choose, spend more time in Taipei or any other part of Taiwan or elsewhere after the Exchange program at my own expense, and responsibility.
9. I hereby release and discharge Rotary International and District 7230, and their respective successors, officers, directors, agents, and employees from any and

all claims, damages, liabilities, or expenses which I or my successors, dependents, beneficiaries, heirs, executors, administrators, or assigns may hereafter have against any or all of such parties on account of or in connection with the Friendship Exchange Program or my participation therein. I agree that I shall indemnify and hold harmless Rotary International and District 7230 and their respective successors, officers, directors, agents, and employees against any and all claims, damages, liabilities, or expenses which any such party may incur on account of or in connection with my participation in the Friendship Exchange Program. The foregoing release and indemnity shall continue to apply to each officer, director, agent, or employee even though such individuals may cease to serve in such capacities and shall inure to the benefit of the legal representatives, successors, and assigns of such individuals. The foregoing release and indemnity shall not apply to the cost of my transportation to and from the receiving district.

10. I agree that I will abide by all the District 7230 decisions related to travel safety. If the District or the Team Leader determines, in its/his sole discretion, at any point in the Friendship Exchange process that my safety as in the host country is or could be at risk, the District or Team Leader may require that the itinerary be modified, cancelled, or indefinitely postponed. If already in the host country, my team may be asked to return home immediately. In such instances, I agree to abide by the District's decision as to what, if any, alternatives are available. Should I be required to return home prematurely due to travel safety concerns, and I choose to stay, I accept all responsibility for my safe return home.
11. I freely accept the conditions outlined above, understanding that the District Friendship Exchange Committee has the final authority to select team members. Team members or alternates may be disqualified at any time, if deemed appropriate, and all such decisions shall be final and binding.
12. I understand that accommodations and travel in the district will be provided by local Rotarians during the tour.
13. To promote understanding and goodwill, I will recognize the right of each person to his/her own opinions and will therefore be cautious about expressing my own personal opinions concerning any controversial, political, racial, or religious issue.
14. Rotary International and District 7230 may share my name and contact details with the Rotary International District 3482, with other Rotary Clubs in 3482, and with alumni groups upon request.

15. Unless I indicate otherwise in writing, I hereby give publication rights to Rotary International and District 7230 for promotional purposes to further the Object of Rotary, including but not limited to Rotary International and/or District 7230 publications, advertisements, and websites. I also authorize Rotary International and/or District 7230 to share photos from my final report with Rotary entities for promotional purposes to further the Object of Rotary. I do not authorize Rotary International and/or District 7230 or any other entity to use these photos for any commercial purpose.
