Assembly/PETS meeting, it

was announced that we had over 90 participants in our five areas where the RLI sessions were offered. We had about 22 of our 43 clubs with at least one member in attendance. That was a great start; however we still wondered why more clubs didn't participate. Wouldn't it be better for our district, in order to be as active and viable as it can be, to have had all 43 clubs in attendance represented by at least 3 or more members?

During our club visits, the request was made of District to provide ideas to assist with membership, or retaining members, or foundation giving, or meeting attendance, or service project participation, or international involvement, or grants for local projects, etc. Our AGs and District RLI Chair provided a great solution; it's called RLI. We will all have another opportunity next year to attend RLI, as it will continue to be offered in our district. I am genuinely excited about the potential these people who attended RLI now have as a result of what they have learned about themselves as leaders along with more information about Rotary. It will be interesting to witness how they will apply that information in their club, their business, and their community. Lead on!

As part of our RLI Sessions, one take-away I had was that our fellow Rotarians are all about collaboration as much as possible – working together – one club helping another. And the strong consensus was that project(s), at least international projects, going forward should be recognized in the name of Rotary, not necessarily only the lead club. It shouldn't be a project of a specific club, even though the lead clubs need to do the project, the work, hopefully with the help of other club(s). We should do our projects, our goodness, our calling, in the name of Rotary. What are our thoughts about this possibility? Does this philosophy for our District grow collaboration for international, or local, projects or not?

## PETS Review

President Elect Training Seminar (PETS) 2013 has come and gone. About  $\frac{3}{4}$  of the in-coming club presidents attended the training. Those president-elects (PEs) not only got training for their year as club presidents but they also (and more importantly) got a chance to visit with each other. The socializing with others is a significant aspect of PETS. District Governor Elect Nancy Moose was PETS organizer. Those PEs who were unable to attend will soon be contacted to arrange appointments for a kind of mini-PETS since Rotary International requires that all club presidents have training.

PETS this year focused a great deal on the new grant model that The Rotary Foundation will launch on July 1, 2013. Past District Governor Pam Russell from San Diego was the speaker and is one of Rotary International's Trainers for the new grant model. Many of the PEs had already attended training sessions for implementing the grant model and had a chance to review the information and to ask questions of Pam. Several PETS attendees commented on the fact that they felt more confident in their knowledge of applying for Global Grants and District Grants.

Another area of PETS that is important to the in-coming presidents was the demonstration of Rotary Club Central, found on the Rotary International website ([rotary.org](http://rotary.org)). Beginning this year, all club presidents must submit their clubs' membership, service, and foundation goals online through Rotary Club Central. Consequently, all club presidents will need to create an account through Member Access and use Rotary Club Central. The RLI program, which was initially introduced to Rotary District 5610 in 2010, was reenergized in the fall of 2012, beginning with a commitment of District Assistant Governors and District Leadership to support and promote the program. Greg Podd, current RI Director from Zone 27 and a proponent of RLI conducted facilitator training and provided motivation to those in attendance.

The district was divided into five regions and courses were offered in each region in January, February, and March. To date, 87 Rotarians have participated in the program and 42 have completed all three courses. A make-up session is being discussed for those who were unable to attend all three sessions, with more information coming. Also, plans are being made to offer the courses in late winter/early spring of 2014, and dates and course locations will be announced following the District 5610 Conference which will be held in Madison, SD on September 12-14, 2013.

## The first place winner's essay by Jadyn Anderson

"Wow. Just. Wow. I've just realized that I have been living my life all wrong. The Four-Way Test is what brought me to believe this. The Four-Way Test is a true test of if you are simply living your own life the way you should be. It is something you should ask yourself every time you make a decision. If you can't answer "yes" to all of the questions that make-up the Four Way Test then you need to rethink what you were just about to do. The Four-Way Test consists of four rules to live by:

1. *Is it the Truth?*
2. *Is it Fair to all concerned?*
3. *Will it build Goodwill and Better Friendships?*
4. *Will it be Beneficial to all concerned?*

**Is it the Truth?** Living with total honesty is sometimes really hard to do, I get it. But if you do live a honest life, you will feel as if you are free to do anything you want. If you lie a lot, the lies will build up. It will feel as if an imaginary elephant of guilt is sitting on your shoulders, and is threatening to crush you at any moment. You don't want to be unable to look someone in the eye when you talk to them. Living in the shadows of your lies will not make you very fun to be around at all.

**Is it Fair to all concerned?** Being unfair will never make you a winner. It will only make you a loser. So if your mom, for example, gives you and your friend each a lollipop and you take your friend's and eat it, your friend won't want to be your friend anymore. You might have felt like you were the one who ended up happy but when you end up with no friends, you will be the one who is crying. So next time, try to think about how your friend will feel. Think about your friend's feeling before your own.

**Will it build Goodwill and Better Friendships?** This rule is probably the most important rule. If people learn how to give more than they receive, the world would just be a happier place. Also, friendships shape who you are today. If the decisions you make right now are bad, you might end up in a bad crowd. But, if you make good decisions now, you will end up with the good crowd. Building friendship bonds with people have everything to do with making the right decisions in life. So, ask yourself this question every time you are dealing with tough decisions.

**Will it be Beneficial to all concerned?** If you don't ask this question to yourself every time you make a decision, that decision may only benefit you, not everyone involved with that decision. If you only think about yourself, you won't have many friends. You have to consider about what they will think when you act self centered. Put them first, not yourself. Think about what you do before you act. Make sure that everyone benefits from your decisions, not just yourself.

I really hope the Four-Way Test helps keep friendships together and even make new friendships. If you drive away everyone you love, you will have a slow-moving, sad, and boring life. Two people can achieve great things when they are together, but when they are apart, they will achieve nothing. I hope whoever comes wandering upon the Four-Way Test like I have, will stick with it until the day they die."

## A Perspective on Media Coverage about New Allies in the Fight Against Polio

By now, many Rotarians and friends of Rotary have read the February 28<sup>th</sup> edition of The Wall Street Journal, which includes a news report as well as an op-ed column about New York Mayor Michael Bloomberg's decision to donate US \$100 million to the Global Polio Eradication Initiative through his charitable foundation.



It's great to have such leaders join our fight. As we all know, over the last three decades, Rotarians have contributed more than \$1.2 billion and countless hours to end this scourge. As advocates and fund-raisers in this cause, we welcome help from all who share our vision, and we thank Mayor Bloomberg for stepping forward. In fact, on behalf of all Rotarians, Dr. Robert S. Scott, chair of our International PolioPlus Committee, publicly thanked the Mayor as soon as the [announcement](#) was made last Friday. At this critical time in the battle, we want and need to encourage other philanthropists and business leaders to join us.

In addition to the Bloomberg donation, the WSJ coverage describes philanthropist Bill Gates' commitment to polio eradication. The Bill & Melinda Gates Foundation has contributed more than \$1.5 billion to fight polio, including the \$355 million challenge grant to Rotarians, who successfully raised more than \$228 million by early 2012. You'll recall that the Gates Foundation was so impressed by our success that they quickly added another \$50 million.

When supporters such as Mr. Gates and Mayor Bloomberg join ranks with Rotary for a cause as important as the eradication of polio, it demonstrates the immense contribution the private sector can make in addressing the world's most pressing needs.

Again, we want and need to encourage philanthropists and business leaders to generously step forward. To achieve this objective, however, we must remember that the world is watching how Rotarians respond when such announcements make the news.

I understand that we may not always like how the media tell the story. However, I believe that we can all agree that announcements such as the Bloomberg donation are urgently needed if we are to win the battle against polio. Let's all remember that polio, after all, is our common enemy. We are in this battle to beat polio once and for all. In short, it is not helpful when we criticize our partners or allies, or even the very media upon whom we rely to carry our message.

Ultimately, history will tell the whole story of how polio was eliminated from the human experience. And, we can be confident that the role of Rotary will not be missed or dismissed. In fact, over the past 18 months, we have greatly increased our PR outreach, and we are seeing significant results. For proof, we need only remember some of the most recent coverage from the world's major media: a cover story in the international edition of [TIME Magazine](#), a full page in [Discover Magazine](#), a first-person column in the [New York Times](#) India web site, and major stories on national networks in Taiwan and Korea. And, let's keep in mind that all of these news reports are just since the start of 2013.

Another thing to keep in mind is that we can and must be confident in our partners and allies. Mr. Gates has repeatedly given credit to our hard work and leadership. As but one of many examples, consider that on the evening of the Bloomberg announcement, Mr. Gates and Mayor Bloomberg appeared on the popular [Charlie Rose](#) television talk show in the United States. During the program, Mr. Gates praised Rotary's leadership in polio eradication: "They've been involved from the very beginning," he said. "We wouldn't be anywhere near where we are without Rotary's key partnership."

I hope you will agree that the quote from Mr. Gates says everything.

As Rotarians, let's welcome announcements of new partners and allies with a spirit of generosity and gratitude. I would deeply appreciate it if you, as District Governor, would share this perspective with your clubs. Ultimately, it is in the best interest of every Rotarian – and all who share our passion to end polio forever – to encourage and welcome more organizations like the Gates Foundation and more individuals like Mayor Bloomberg.

As the spring storm season approaches, it's time to begin preparing for potential natural disasters. In anticipation of such events as tornadoes and floods, the Disaster Relief Committee is planning a survey of District 5610 Rotary Clubs to determine in which types of disaster relief activities clubs may be willing and able to participate if called upon to provide assistance.

Following a natural disaster, clean-up activities are generally an early priority and many hands are needed to regain some semblance of order. A variety of skills are needed, from manual labor to craftsmen and women, plumbers, electricians, carpenters, etc. While we don't anticipate widespread volunteering of skilled labor, we do anticipate that many clubs would identify a cadre of individuals who would give a day or two or three of their time, and perhaps their talent, to assist those within our district who have a need. Although many of us would like to travel the world to assist in water projects, solar oven assembly and training, fitting wheelchairs, administering polio anti-virus serum, and countless other selfless activities, it's not always feasible to do so. By helping fellow Rotarians in their communities in our district, we can perhaps offer "Service Above Self" to those who need and appreciate our assistance.

On behalf of the Disaster Relief Committee, I encourage every Rotary, Rotaract, and Interact club, to complete the survey when you receive it.

## Grants Training at PETS

For those of you not at PETS this past week we had Pam Russell from California speak about the new Grants model. She was in a pilot district and has been doing training about the new procedures. She related the positive feedback she has heard about the new procedures and expectations. If you haven't heard about it... when obtaining a new grant going forward we are requiring more work up front to make sure the focus of the project is what is needed by those you are intending to help. In the past, it's often been that we have a project we think is great and we take it somewhere. Now, we need to listen to the recipient group to make sure we are providing resources that they need. It's like the story of the lady who was doing fundraising for a number of years to pay for school uniforms for children in Africa so they could attend school. One year, some of the villagers asked her if she really wanted to help them. She said, "of course, I have been raising money for years to provide uniforms!" They told her the best way to help would be to help them buy some water buffalo so they could till more land, sell milk, etc. so that they could buy their own uniforms. We need to have boots on the ground and to listen to find out what the real need is!

There is also the expectation of better recordkeeping and reporting. All of these are being required in order to make sure that we are being good stewards of the money we are being trusted with. Nothing less than what you would want! If you have any questions about the new requirements or the process of putting a grant together, please get a hold of me. We have a number of people who are able to give you some guidance in the details. Remember to think big and think sustainable!!

# RI News // Rotary Peace Fellows

## Do You Want To Change The World? Or Do You Know Someone Who Does?

If so, Rotary International might have the program to help with this goal. In 2002 the Rotary Foundation partnered with leading universities around the world to create Rotary Peace Centers for International Studies in peace and conflict resolution. Today, up to 110 Rotary Peace Fellows are selected each year from around the world to participate in this unique program funded by Rotary International. The fellowship includes tuition and fees, room and board, round trip transportation and internship/field study expenses. Peace Centers are located in Australia, Japan, Sweden, Thailand, United Kingdom and Chapel Hill in North Carolina.

Rotary Peace Fellows are leaders promoting national and international cooperation, peace and conflict resolution in their careers and communities. Fellows are selected, based on their ability to have a significant, positive impact on world peace during their careers. Qualified candidates for the master's program will have a bachelor's degree or equivalent plus three years related work experience. These candidates must also speak a second language. A certificate program is also offered for candidates with a strong academic background plus five years of related work experience. The certificate program does not require a second language. Both require proficiency in English.

Candidates must apply through a Rotary Club. District 5610 has provided information to colleges and universities in this district but all Rotarians need to promote this program. The district is not limited to the number of applicants we recommend.
