DG Report: Linda Peterson

The 110th birthday of Rotary is February 23! Plan an event or notice at your club meetings to commemorate this anniversary of our world-class organization!

It's the time of year we are all deep in club projects, membership inductions, orientations, and committee work. Since the Rotary year is midway, here's my analysis of where we are as a District of 43 Rotary clubs, 1 satellite club and 2 Rotaract clubs:

- 1) We are in good financial shape, with our IRS 990 current for 501(c)4 status. Our District has billed dues to clubs and clubs are paying dues on time. Club RI dues are now available to pay.
- 2) We have increased membership to 1957, up 21 members since July. Good work, but we can't stop yet! Our goal is 2077 by July!
- 3) Our Polio giving is very high, at \$15,743 in December, over our goal. But our Foundation annual funding is not as good, at \$33,822, less than 70% of goal, and less than half of our clubs participating. We must emphasis our need to contribute to our four-star-rated charitable Foundation.
- 4) Our online access could be improved: 25 club presidents, 34 secretaries, and only 19 treasurers are registered on the RI website with access as of January. Since our organization is mostly online, we need to be 100% with access, to complete goals, list board members, and find information.
- 5) RLI continues in our District, offering an excellent opportunities to learn more about Rotary and brush up on leadership skills. Great new member orientation!
- 6) Our leadership is continued to train, plan and meet regularly. Our next event is training incoming presidents and other District leaders, and all club and district leaders should attend.

Grants approved for 2014-15 District Designated Funding

We have six excellent new projects recently approved by the District Foundation Committee and funded from The Rotary Foundation's District Designated Fund. Details below. In addition, we have a Global Scholarship recipient, Emily Nachtigal, studying in Belgium. Dave Lorenz did an excellent job working through the application and all the nuts and bolts to get Emily on board and approved at TRF for her scholarship. We look forward to hearing about her studies and adventures in Belgium.

The India Sewing Machine project is now in process for a global grant with the participation of several clubs and members throughout the district.

Several other global grants are being developed in the district – joining the Guatemala and Panama global grants with Vocational Training team members, funding Project C.U.R.E. in Haiti, and a project in Romania. As these projects are developed, look in this space for more information.

Here are the details on this year's District Grant projects:

Rapid City RC \$5,000 award: Educational programming at the Journey Museum & Learning Center. They are partnering with The Club for Boys and South Dakota GEAR UP as well as the Journey Museum.Rapid City

Rapid City Rushmore RC, \$2,500 award: Provide cows, rabbits and animal sheds for Nibakure Children's Village in Nyamata, Rwanda.

Sioux Falls South RC, \$5,000 award: Food packages for overseas and local backpack programs. They are partnering with Kids Against Hunger and have brought on several other Rotary Clubs to work with them.

Vermillion RC, \$2,000 award: Encourage new schools to participate in the South Dakota spelling bee. They are working with the University of South Dakota and would like other district clubs to participate with them.

District 5610 Foundation Committee, \$3,000 award: First annual Foundation and Grants Seminar and Awards Dinner.

SDSM&T Rotaract Club, 2 grants: \$5000 for water project at Vocations for Orphans in Vicuna, Chile. \$3250 for a water project continuation at Ilboru Special Needs School in Miovo Ward, Arusha, Tanzania. **Mitchell Second Chance Interact Club:** \$498.40 for science enrichment for Sixth graders at Science Saturday programs.






Friendship Exchange with D4740 in Brazil proposed

- 1. Set your Membership Teams.
- 2. Promote the Program.
- 3. Be sure teams meet and discuss their progress.
- 4. Celebrate your Success.
- 5. Report your Progress.

HAVE A 'BRING A GUEST' MEETING:

- 1. Determine which week to designate "Bring a Guest."
- 2. Remind members that the most common reason for not joining Rotary is that "Nobody ever asked me."
- 3. Provide information to members to give to potential new members and guests.
- 4. Introduce guests and make them feel welcome at your meetings.
- 5. Call and send a hand-written "Thank you" to guests and be sure to invite them back.

FOCUS ON SMALL BUSINESS WITH A SPECIAL EVENT:

- 1. Plan an event outside your regular meeting aimed at small businesses and entrepreneurs.
- 2. Develop a list of people to invite.
- 3. Get a list of business owners to consider as potential Rotarians.
- 4. Consider pre-approving potential members prior to your event.

5. Consider sending letters to select people telling them they have been pre-approved to become a Rotarian and what that means.

6. Hand deliver Invitations to special businesses.

INCLUDE PROSPECTIVE MEMBERS IN YOUR COMMUNITY SERVICE PROJECTS:

- 1. Invite potential members to participate in your Service Projects.
- 2. Try to get local PR at your events.
- 3. Encourage the guests to also bring their families to help.
- 4. Be sure to introduce guests to as many members as possible.
- 5. Hold an event after the project to socialize more.
- 6. Share with the guests all the things your club does for your community.



Zone 21b-27 Presidential Membership Summit Report

8-10 January 2015, Marriot Pyramid Hotel and Convention Center, Albuquerque, NM

PDG and District 5610 Membership Chair **Vivian Adams** and IPDG **Nancy Moose** attended the Membership Cadre Training and the Presidential Membership Summit held on January 8-10 in Albuquerque, NM. The Summit was organized by Dick Jones and David Norris, Coordinators of Zones 27 and 21b, respectively.

Rotary Zone 21b/27 Director Greg Podd has asked Dick Jones and David Norris to create a Membership Cadre whose assignment is to go to districts, to PETS, to assemblies, to individual clubs, to groups of Rotarians, to anyone who wants to help grow membership in Rotary and provide training and tools for gaining members. Rotary International has been trying to reverse the trend of declining membership in Rotary, especially in the US. Consequently, during these past few months, every district in Zones 21b-27 has been appointing members to the Cadre and arranging for them to be trained.

Thursday was a training day for members of the Cadre who had not previously attended training. Thursday evening was the official start of the Summit, and it started off with Immediate Past Rotary International President Ron Burton as the keynote speaker. He commended the Zones for the increase in members (over 500 new members) this past few months, but he urged the attendees to use their training to continue the upward trend. He commented on the fact that he has been talking about membership and about the elimination of polio for years and that he's tired of it, but until both problems are solved, he'll carry on talking about those topics.


Other speakers during the summit were Rotary International Director Elect for Zone 25/26, Brad Howard, who provided some Polio updates and an overview of the state of Rotary; PDG Joe Kavorik of Minnesota, who explained the importance of strategic planning in our districts and clubs; PDG Dan Himelspach of Denver, who discussed the value and use of satellite clubs; Gary Nyng, who pointed out the various kinds of diversity, and Chris Smith, who provided information about how to tell our Rotary story as a way to enhance Rotary's public image.

Two of the most interesting presentations were from Larry Sundram and from a group of young professionals. PDG Larry Sundram of San Diego, who has created a mapping program that shows the number of Rotarians in any area of the US, along with census data of those same areas, gave attendees a chance to see how the program could be used to find areas with potential Rotarians and areas where a potential Rotary club could be formed. The report from Rotary International's Young Professional's Summit by Zone 21b/27's Young Professional Summit Attendees provided both information and enthusiasm. The five presenters noted that they are "just Rotarians" and that they join Rotary for a lot of the same reasons any person joins: they want to serve and they want to make a difference. Rotary gives them a way to network, to grow in their careers, learn from others, and to serve.

The Summit ended with Rotary Zone Director Greg Podd, a person who is well-known in our district, as our luncheon speaker. He, like Ron Burton, encouraged the attendees to keep membership as a top priority. All of the Zones' leaders have been tasked with supporting all efforts related to gaining members.

The Presidential Membership Summit was motivational, as is any conference, but it went one step further in providing specific tools and ideas for helping to grow membership in Rotary. It's now up to the districts and clubs to invite members of the cadre to come and help them in their efforts. Costs for having a cadre member come to a district or club will be funded by the Zone, not the districts or clubs.







Rotary Leadership Institute

Someone once said "a mind, like a rubber band once stretched, never returns to its previous size." I don't remember the source of that statement, but I've not forgotten the message. In this age of social media, such a post on Facebook would probably generate an endless exchange of disagreement, many posts ignoring the intended point of the statement. However, it is not my intent to create such discourse here, but rather to encourage you, if you have not done so, to "stretch" your mind by attending one or more RLI sessions in your area.

We have developed a cadre of over 30 facilitators who are eager to open discussions that are interesting and informative among Rotarians. If there are no courses scheduled in your area, contact the Assistant Governor for your area to get one set up, or contact me and we'll work together to get started.

There are no negative consequences to not completing the entire program. And there is no exam, no humiliation—public or private, but a clearer vision of Rotary and your place in it. It will help you answer some of your questions of "Why did I join Rotary?" It is truly a way to "Light Up Rotary!"



School of St. Jude Support Project

A number of Rotarians and clubs in our District already support the School for St. Jude in Tanzania. We have had personal visits to our District from Gemma, who started the school. If you do support, thank you! For those who would like to provide support, but do not have the resources for the full donation, here is a new option being proposed.

PROPOSAL: To best serve clubs who want to contribute to the School of St. Jude project, a separate district account would be opened so that all interested clubs can donate to The School of St. Jude by sending their checks to this account. It would only take \$100 to \$200 (more would be great if the club wishes) to get involved and when the total reaches \$1500 we would send it to The School of St. Jude to **sponsor a child and a teacher**. This would be an annual commitment as the child needs to be sponsored every year. The sponsorship for the student includes uniforms, shoes, food, clean water, transportation to and from school, school supplies and a high quality education. In the upper grades it also includes boarding as fourth grade through eighth board at the school during the week and from ninth grade on the students board at the school for the whole semester. For the teacher it provides classroom supplies.

REASONS FOR PROPOSAL: The School of St. Jude needs sponsors for the children that they are educating. Many clubs in our district could use an easy way to get involved in an international project and this project will give them lots of feedback from the school and the student to truly show them that they are helping to change the world. The students write letters to their sponsors twice a year and their grade reports are also sent to the sponsor. Also if the student wins an award the sponsor is sent a picture of the student and a description of the award.



Rotary District 5610 Foundation Raffle

We will once again be holding a raffle to raise funds for the Rotary Foundation. February 1: Tickets sent to club Presidents and Secretaries for sale to club members.

April 1: Reminder to clubs to sell tickets prior to PETS.

April 9-11, 2015 PETS Conference: Drawing for prizes.

May 1: Publish a list of prize winners in the District Newsletter.

Raffle Rules:

- 1. Clubs will be required to send the money directly to the Foundation, just as they do with any other Foundation donations. A form will be provided for you to turn in with your tickets, documenting how much was sent to the Foundation on behalf of each raffle ticket holder.
- 2. Raffle ticket purchases are not tax deductible. If a member wishes for their Foundation donation to be tax deductible, they cannot be given any raffle tickets in return for their donation. (This is due to IRS rules not allowing tax deductions for purchases in which there is a chance of winning a prize.)
- 3. Tickets are \$10 each. Tickets will be awarded for Foundation donations in the increment of 1 ticket for every \$10 in donation. For example, if a member donated \$100 to the Foundation, and does not plan on taking the tax deduction for charitable giving, they will be awarded 10 raffle tickets.
- 4. Only Foundation donations from the current fiscal year can be applied to this year's raffle. Donations prior to July 1, 2014 cannot be applied to this year's raffle.
- 5. Credit will be given toward Paul Harris Fellow status of the Rotarian selling the ticket for tickets sold to people outside of Rotary.
- 6. Raffle tickets can be awarded for individual Foundation donations only, not for Club donations.
- 7. All clubs in District 5610 are asked and encouraged to donate a prize for the raffle. Prizes with a local connection are very nice, but cash and gift cards are also welcome.
- 8. Tickets are due back at the District PETS conference in April.
- 9. All prizes will be drawn and awarded at the PETS conference.
- 10. Names of prize winners will be published in the May District 5610 Newsletter.




PROGRAMS

PolioPlus. Since 1985, Rotary members have helped immunize more than 2.5 billion children against polio. Today, all but three countries are free of polio. As of June 2014, Rotary had committed more than \$1.3 billion to global polio eradication to ensure that polio is eliminated in the last three countries where it remains and that it does not return elsewhere. In 2013-14, program awards, including PolioPlus Partners grants, totaled \$128.9 million.

Rotary Peace Centers. Each year, the Foundation funds study by peace fellows at six Rotary Peace Centers, where they earn master's degrees or professional development certificates. Since 2002-03, more than 875 fellows from more than 120 countries have participated, at a cost of \$49.6 million. In 2013-14, there were 98 Rotary Peace Fellows from 41 countries, and program awards for the fellows and the Rotary Peace Centers totaled \$5.3 million.

2013-14 TOTAL CONTRIBUTIONS*



All figures are as of 30 June 2014 and given in U.S. dollars.

District grants. District grants support smaller-scale, short-term projects related to the Foundation's mission. In 2013-14, the Foundation approved 488 district grants, and program awards totaled \$23.5 million.

Global grants. Global grants support largescale international activities with sustainable, measurable outcomes that support Rotary's areas of focus; activities include humanitarian projects, scholarships, and vocational training teams. In 2013-14, the Foundation approved 868 global grants, and program awards totaled \$47.3 million.

Packaged grants. Packaged grants, which also support the areas of focus, have been carried out with the Foundation's strategic partners. In 2013-14, the Foundation approved 18 packaged grants, and program awards totaled \$530,000. Note: Packaged grants were ended as of October 2014.

The Foundation works

The start of a New Year! It brings excitement and sometimes apprehension of another year gone by and another year older. But have you ever stopped to think of the people you have helped to be around for another year and whose children will be another year older because they had safe drinking water or were educated or were trained in a skill that will help them to make a living for themselves instead of relying on handouts or who are now able to get from one place to another because of the wheelchair they now have? You have made all of these things possible when you have given money to The Rotary Foundation. You haven't given a handout you have given a hand up to millions of people around the world.

I recently went on a trip to Guatemala to help deliver water filters to families. The filters were first used in the schools and the families realized the value of them because the children were healthier and able to attend school more because they weren't sick. They started asking for the filters for their homes so the children had safe drinking water all of the time. The filters weren't just given out. The families had to pay for them based on their ability to pay and signing a memorandum of understanding that they agreed to three things:

1. They had to use the filter as much as they could.

2. They couldn't sell the filter. If they did they had to pay back the entire cost of the filter.

3. They had to allow for inspection of the filters to make sure they were there, being used and that they were working properly.

I tell you this so that you know how your money is being used. It doesn't go into a black hole and that someone, a Rotarian, is watching over the program and making sure the money is being for the intended purpose. No one wants to give money to an organization that is wasting money. The Rotary Foundation has many safeguards in place to make sure that the money is being used properly.

There is only six months left in the Rotary year. Have you given anything to The Rotary Foundation or are you a RINO (Rotarian In Name Only)? Rotary asks that you contribute at least \$100/year to the foundation. I hope that's not too much to ask for a chance at helping to make the world a better place.

Finally, it's not to late to be working on your grants for the coming Rotary year. We ask for applications soon after July. This is a chance to get a project going to help in your community or around the world and to get some of the money back that you have given to The Rotary Foundation three years ago. 
