

2025-26 Global Grant Scholarship Application

District 5870 Rotary Global Grant Scholarships, in the amount of \$30,000 each, will be awarded to fund post-baccalaureate study at an accredited college/university located outside the United States, and its territories. Applicants must study in one, or more, of the seven Areas of Focus. Rotary must have a presence in the area so a local club may serve as host. Scholarships are for a period of one to four years.

Applicants: Complete the application and secure the required documents, transcripts, letters of recommendation, and language proficiency. **The application, and all required materials, must be received by the local Rotary club no later than Monday, November 4, 2024.** The Club will schedule and conduct interviews, notify the Club's nominee, and advise those not selected.

District interviews are scheduled for **Saturday**, **December 14**, **2024**. Applicants must know the college/university he/she plans to attend by the time of the interview.

When the candidate is chosen by the District, the application process to The Rotary Foundation begins immediately. Scholars are required to gain admission to the college/university he/she wants to attend. Admission is required before the Foundation will approve the application. District secures a host club. The local club, the candidate, and the host club will complete the on-line application.

A humanitarian service project will be required if the approved educational expenses (room, board, tuition, travel to/from the college/university at the beginning of study and at the end, required immunizations, medical insurance, and reasonable living expenses) are less than \$30,000. Applicants will be expected to provide an outline of the project, and its anticipated budget, during the District interview.

Candidates are expected to appear in person for the District interview, if possible.

PLEASE NOTE AGAIN, the completed application and all required supplemental materials must be received by the local Rotary club no later than Monday, November 4, 2024.

1. Peace and Conflict Prevention/Resolution _____

Scholars in this area are expected to study ways to prevent and mediate conflict, and to support peace-building in communities and regions affected by conflict. Preferred academic programs include conflict prevention/resolution, peace and justice studies, and international relations or law with a specialization in peace and conflict. Programs will:

- A. Be considered favorably that include a focus directly on peace and conflict issues; and
- B. Will not be considered favorably that relate to general international relations or law.
- 2. Maternal and Child Health __

Scholars in this area are expected to study ways to improve the health of mothers and their children by:

- A. Reducing the mortality and morbidity rate for children under the age of five;
- B. Reducing the maternal mortality and morbidity rate; and
- C. Improving access to essential medical services, trained community health leaders and health care providers for mothers and their children.

Preferred academic programs include epidemiology, nutrition, global health, public health, and health promotion and degrees in nursing and medicine.

3. Disease Prevention and Treatment

Scholars in this area are expected to study ways to prevent disease and promote health by:

A. Improving the capacity of local health care professionals;

- B. Promoting disease prevention programs, with the goal of limiting the spread of communicable diseases and reducing the incidences of and complications from noncommunicable diseases;
- C. Enhancing the health infrastructure of local communities;
- D. Educating and mobilizing communities to help prevent the spread of major diseases; and
- E. Preventing physical disability resulting from disease or injury.

Preferred academic programs include public health, advanced degrees in nursing and medicine.

4. Basic Education and Literacy _____

Scholars in this area are expected to study ways to ensure that all people have sustainable access to basic education and literacy by:

- A. Involving the community to support programs that strengthen the capacity of communities to provide basic education and literacy to all;
- B. Increasing adult literacy in communities; and
- C. Working to reduce gender disparity in education.

Preferred academic programs include education, literacy, curriculum development, special education, and school administration.

5. Water and Sanitation _____

Scholars in this area are expected to study ways to ensure that people have sustainable access to water and sanitation by:

- A. Providing equitable community access to safe water, improved sanitation and hygiene;
- B. Strengthening the ability of communities to develop, fund and maintain sustainable water and sanitation systems; and
- C. Supporting programs that enhance communities' awareness of the benefits of safe water, sanitation and hygiene.

Preferred academic programs include water science/engineering, water management, environmental science, epidemiology, and parasitology.

6. Economic and Community Development

Scholars in this area are expected to study ways to invest in people by creating sustainable, measurable and long-term economic improvements in their communities and livelihoods by:

- A. Building the capacity of entrepreneurs, community leaders, local organizations, and community networks to support economic development in impoverished communities;
- B. Developing opportunities for productive work;
- C. Reducing poverty in underserved communities; and
- D. Preferred academic programs include social science degrees with a specific focus on economic and community development, and business degrees tailored for social business or microcredit.

Programs that will be favorably considered include those that:

- A. Focus on grass-roots economic development strategies;
- B. Focus on addressing economic issues of poor and underserved communities;
- C. Support social business development; and
- D. Include "community development" in the name of the program or tailored track.

Programs that will not be favorably considered include those that:

- A. Focus on purely theoretical or macro-level economics;
- B. Support general private business development; and
- C. In a general way to the field of community development but do not include "community development" in the name of the program or tailored track.

Careers that will be considered favorably include those that either;

- A. focus on improving the economic well-being of poor and underserved communities; and/or
- B. In a non-profit or social enterprise environment.

Careers that will not be considered favorably include those that focus on general business activities in a private or corporate setting.

7 .Environment ____

Scholars in this area are expected to study ways to protect and restore land, coastal, marine, and freshwater resources by:

- A. Supporting agroecology and sustainable agriculture, fishing, and aquaculture practices to improve ecological health;
- B. Addressing the causes of climate change and climate disruption and supporting solutions to reduce the emission of greenhouse gasses;
- C. Strengthening the resilience of ecosystems and communities affected by climate change and climate disruption;
- D. Supporting education to promote behaviors that protect the environment;
- E. Advocating for the sustainable consumption of products and the environmentally sound management of byproducts to build a more resource-efficient economy; and
- F. Addressing environmental justice issues and environmental public health concerns.

III. APPLICANT CERTIFICATION

I hereby apply for a Rotary Foundation Global Grant Scholarship from Rotary District 5870 and certify that I am eligible to apply, understanding that persons in the following categories are ineligible:

- A. Rotarian or Honorary Rotarian;
- B. An employee of a Rotary club or district, of Rotary International, or of another Rotaryaffiliated entity;
- C. Spouse, a lineal descendant (child or grandchild by blood or adoption), a spouse of a lineal descendant, or an ancestor (parent or grandparent by blood) of any living person in the foregoing two categories; and
- D. Rotarians and their relatives described above remain ineligible for 36 months after resignation.
- E. Prior to the district scholarship interviews, which are currently scheduled for <u>December</u> <u>14, 2024</u> I understand that I am required to:
 - a. Identify the college or university that I want to attend;
 - b. Demonstrate that I am proficient in the language of the country this college or university is located;
 - c. Work with my sponsoring Rotary Club to complete my estimated budget expenses as outlined in the *Global Grant Scholarship Handbook*; and

d. Develop an outline of my humanitarian service project (if required), a budget as outlined in the *Global Grant Scholarship Handbook*, and be prepared to discuss the project at the District scholarship interviews.

I further certify, understand, and agree that I am solely responsible for gaining admission to the college/university that I want to attend, and for obtaining required visa(s), passports, making appropriate travel arrangements, required immunizations, medical insurance, and completing all pre-departure travel requirements. I must gain admission to the college/university that I want to attend before my Scholarship Application can be submitted to the Rotary Foundation.

If I receive a Rotary Foundation Global Grant Scholarship, I understand and agree:

- A. The academic program I am undertaking must be no shorter than one academic year in duration, nor longer than four years;
- B. That the program of study must be for post-baccalaureate work only in one or more of the seven Areas of Focus established by The Rotary Foundation;
- C. To abide by any decisions made by Rotary District 5870 and/or my sponsoring Rotary Club concerning my scholarship; and
- D. That, as noted above, I may be required to complete the humanitarian service project during my period of study.

I further understand that the project must be:

- A. Conducted in the Rotary District of my international host Rotary Club;
- B. In the same Area(s) of Focus as my academic studies;and
- C. Executed during the scholarship period.

I will be expected to adhere to the Terms and Conditions for Rotary Foundation Global Grants, and my scholarship studies can begin no earlier than 90 days after my Rotary Foundation Global Grant Scholarship is approved by The Rotary Foundation, and that I will not receive reimbursement for any expenses incurred prior to this date except for the items listed in paragraph 3 above, and I must obtain the following minimum insurance coverage:

- A. \$250,000 or equivalent for medical care and hospitalization for basic major medical expenses, including accident and illness expense, hospitalization, and related benefits;
- B. \$50,000 or equivalent for emergency evacuation;
- C. \$20,000 or equivalent for repatriation of remains; and
- D. That the scholarship funding is \$30,000. Scholarship funding is for only those items contained in the approved budget and can only be used for:
 - a. Studies i.e., tuition, books, lab fees, other classroom and/or school fees, travel to and from my county of study at the commencement and end of the scholarship and reasonable living expenses; and
 - b. Completion of my humanitarian service project, and that I will need to seek alternate sources of funding if costs exceed \$30,000;

That Rotary International, Rotary Foundation, Rotary District 5870 and my sponsoring Rotary Club assume no responsibility or financial obligation whatsoever beyond providing the amount

of the funding contained in the approved budget; that I am expected to learn about Rotary International and fulfill the following ambassadorial responsibilities:

- A. Attend any orientation programs organized by District 5870 and/or other districts, or by my sponsoring Rotary Club;
- B. Before departure, attend meetings of my sponsoring Rotary club and Rotary events in our district as invited, and present at least one talk to a Rotary group;
- C. Make myself available for, and encourage, media interviews at home and abroad;
- D. Maintain academic studies with distinction, giving equal importance to the academic and ambassadorial aspects of your scholarship;
- E. Be actively involved with Rotary in my international host district, making presentations to Rotary and non-Rotary audiences, and submit required reports to Rotary District 5870 describing my academic progress activities;
- F. Present talks to Rotary and non-Rotary audiences within the first year after my return home;
- G. Maintain communication with my sponsor and host Rotary Club before, during, and after my study period;
- H. Offer to share my experiences at Rotary clubs or district meetings, and participate in Rotary Foundation alumni activities;
- I. Register contact information with Alumni Relations at the Rotary Foundation, keeping my address, telephone number and e-mail address updated at all times;
- J. That I must live in the immediate vicinity of my approved study institution and my international host district, so that I can participate in the Rotary club and district activities of the host district;
- K. That I am responsible for all costs associated with my spouse or dependents who may accompany me during my scholarship period;
- L. That I am expected to embrace Rotary's spirit of volunteerism and engage in volunteer activities from the time of the scholarship application, through the term of the scholarship, and to a post-term commitment in my local community;
- M. My scholarship does not guarantee that I will earn a degree, diploma, or certificate;
- N. That I must advise Rotary District 5870 of any other stipend or grant received during my scholarship year;
- O. To help promote Rotary International wherever possible and permit The Rotary Foundation, Rotary International, Rotary District 5870, and/or my sponsoring Rotary Club to use my name and all photographs and written reports generated through any of my activities related to my scholarship;
- P. That my scholarship may be revoked for any of the following reasons:
 - a. Failure to maintain a good academic standing pursuant my college's or university's standards throughout the scholarship period;
 - b. Evidence of misconduct;
 - c. Failure to submit required reports on time;
 - d. Change in study program without the consent of Rotary District 5870;
 - e. Withdrawal from institution before expiration of the scholarship term;
 - f. Failure to adequately fulfill ambassadorial duties;
 - g. Failure to attend an outbound orientation seminar as required;

- h. Failure to follow the directions of my sponsoring Rotary Club;
- i. Failure to provide my sponsoring Rotary Club with my current information including mailing address, telephone numbers, and e-mail address at all times;
- j. Failure to maintain monthly communications with my sponsoring Rotary Club;and
- k. A contingency that prevents me from fulfilling all the obligations of the scholarship.
- Q. That revocation of my scholarship shall cause all payments to cease and may make me personally liable for the return of payments previously provided;
- R. That Rotary International, The Rotary Foundation, Rotary District 5870, the study institution, and individual Rotary clubs and Rotarians are in no way liable for my personal welfare or responsible for enabling my to pursue studies beyond the scholarship period; and
- S. Rotary International, The Rotary Foundation and Rotary District 5870 assume no responsibility or obligation whatsoever beyond providing the amount of the scholarship.
