(1000 characters or less) Our annual club visioning activity has helped us work together as a team to define our direction and goals for the next Rotary year. Our club has held a visioning event every spring since 2016. Conducted by a trained facilitator outside of the club, team members gather after a hosted lunch to brainstorm the following topics: Club strengths, Club weaknesses, Opportunities for our community, and Challenges facing our community. Statements are posted

on charts as participants share their thoughts. After brainstorming, consolidating, and prioritizing the group selects 4-6 of the ideas to implement. Action Planning teams are established, and the teams then meet to plan. Six weeks after the Visioning, the teams report their plans for implementation at a Club Assembly. The enthusiasm and commitment from our club to put into action these new ideas have set collaborative path for engaging members.
