***Would you like to proudly display the U.S. Flag at your home or business on U.S. Holidays,*** and support your Country, Community and Honor those who serve our Country? Would you like to join the many other Hays citizens who already proudly display the American Flag?

The Kiwanis Club of Hays provides this service in the Hays area. For \$40 we will provide a 3'x5' U.S. Flag, a pole and a bracket for proper display of the U.S. Flag on the following five United States holidays:

Memorial Day	Flag Day
Independence Day	Labor Day
Veterans Day	

On those five holidays, the Kiwanis Club will place the flag out at sunrise and retire the flag at sunset at your location within the city limits of Hays. It's as easy as that! You don't have to buy a flag and pole, you don't have to store the flag and pole, you don't have to look for the flag and pole on those holidays, you don't even have to remember the holidays, and Kiwanis will do all that for you.

The Kiwanis Club of Hays has been serving the Hays community since 1953 and is a part of Kiwanis International, *A global organization of volunteers dedicated to changing the world one child and one community at a time.* Kiwanis members are your neighbors and desire to make Hays the best place in the world to live and raise a family.

# FLAG AGREEMENT

THIS AGREEMENT is made this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, between KIWANIS CLUB

for the placement of a flag at \_\_\_\_\_(Address)

1. For the sum of Forty Dollars (\$40.00), which is to be paid upon execution of this Agreement by Customer, Kiwanis agrees to place a 3'x 5' American Flag, pole and mounting bracket or stand at the Location on the following days each year as long as weather permits.

Memorial Day	Labor Day	Flag Day
Veterans Day	Independence Day	

2. A mounting bracket or some other holding device will be necessary for the placement of the pole and flag. Kiwanis and Customer will endeavor to agree as to either the method of attachment to the building or placement in the yard. If there is no Agreement, then either Customer or Kiwanis may cancel this Agreement. It is agreed that once a location has been determined for the placement of the bracket or other holding device, Kiwanis has the right to utilize that bracket or holding device for the remaining times that the flag is displayed at Customer's Location.

3. Kiwanis agrees that on the above days it will place the flag and pole at the Location, and it shall remain there until removed by Kiwanis that same day at approximately sunset.

4. Kiwanis and Customer acknowledge the possibility of winds or other natural occurrences that may occur in Kansas, that could cause the flag and/or pole to be blown down, causing damage to property or persons. Both also agree that the attachment of the bracket or holding device causes an alteration and/or damage to the building or grounds where it is attached. Customer does hereby release Kiwanis of and from any and all liability of any kind or nature, resulting or arising from the installation or flying of the flag, including resultant damage of all kinds to persons or property should the bracket, installation, pole or other device associated with the flag fail or be destroyed. In any event, the limit of liability of Kiwanis shall be the contract price of this Agreement.



5. It is agreed that Kiwanis can cancel this Agreement at any time. In the event the Agreement is canceled, Customer shall be entitled to a refund of the fee paid hereunder, based on a pro rata distribution.

6. Customer shall not be liable for any damage to the flag unless it was caused by the Customer's own negligence or intentional act or any person acting under or in the control of or related to the customer.
