



Key Highlights

Revenues

- Contributions were favorable to budget by \$0.9M, primarily due to Annual Fund \$0.8M, Grant Cash and Term Gift \$0.4M Polio Plus Grant \$0.2M and were partially offset by Endowment Fund (\$0.5M).
- Net investment return was \$9.2M, which is \$7.5M higher than budget.

Expenses

- Program awards were over budget by \$3.5M due to Global Grants over budget by \$2.7 M, and PolioPlus program over budget by \$0.8M.
- Operating expenses were favorable to budget by \$0.3M.



REVENUES

CONTRIBUTIONS

TRF(C) is a Canadian registered charity supported solely by voluntary contributions from Rotarians and friends of The Rotary Foundation who share its vision of a better world.

Contribution revenue in fiscal year 2020-21 was \$11,589,455 (\$10,476,003 for FY20). During the year, TRF(C) received two new unconditional multi-year pledges totaling \$471,622 (nine unconditional pledges totaling \$731,522 in FY20).



NET INVESTMENT RETURN

In fiscal year 2020-21, net investment returns from TRF(C)'s Canadian investment portfolio and endowment investment portfolio held with The Rotary Foundation were \$9,167,796 (\$1,120,175 in FY20). The rate of return was 14.01% for the Canadian investment portfolio, and 30.5% for the endowment investment portfolio.

The endowment investment portfolio held with The Rotary Foundation is denominated in US dollars and is subject to unrealized foreign exchange adjustments at year-end. The endowment investment balance at year-end was \$26,730,650 (\$22,311,899 in FY20). The Mawer investment portfolio is denominated in Canadian dollars and the balance is \$21,449,780 (\$21,295,941 in FY20).

CANADIAN ENDOWMENTS

As of 30 June 2021, there were 120 endowed funds within the Endowment Fund of TRF(C) with a market value of \$26,730,650. In FY2020-21, seven (7) new named endowments were established and total endowment fund contributions from Canadian Rotarians were \$1,255,306. Net investment return was \$6,486,345 in FY2020-21. Rate of return for the FY2020-21 was 30.5%.

INVESTMENT POLICY

The Rotary Foundation (Canada) Board adopted The Rotary Foundation of Rotary International's investment policy and invested its endowment fund contributions together with The Rotary Foundation of Rotary International to maximize earning potential. The Funds are invested in accordance with the investment policy approved by The Rotary Foundation of Rotary International's Trustees and monitored by its Investment Advisory Committee.

SPENDABLE EARNINGS

The Rotary Foundation (Canada)'s Board adopted The Rotary Foundation of Rotary International's spendable earnings policy which includes distributing a portion of investment earnings on endowment funds towards program awards and expenses.

In FY2020-21, spendable earnings totaled \$973,016 of which \$796,165 will be spent towards programs based on donor's designations and \$176,851 towards fund development and general administration.

EXPENSES

Total expense in the fiscal year 2020-21 was \$13,313,409 (\$9,840,431 in FY20). From that amount, \$12,654,402 (\$8,997,418 in FY20) was spent on programs, \$311,201 (\$438,700 in FY20) was spent on fund development, and \$347,806 (\$404,313 in FY20) for general administration expenses.


The Rotary Foundation (Canada) supports a variety of local and international charitable and social welfare programs and activities that advance world understanding, goodwill, and peace through the improvement of health, the support of education, and the alleviation of poverty.

TRF(C) programs consist of the following:


- PolioPlus program provides funding, mobilizes Rotary volunteer support, and promotes polio eradication around the world;
- Global humanitarian projects and packaged projects are strategically focused, high-impact international activities with sustainable and measurable outcomes in the areas of: peace and conflict prevention & resolution, disease prevention and treatment, water and sanitation, maternal and child health, basic education and literacy, economic and community development and environment;
- District-level projects that enable Rotary clubs and districts to address immediate needs within their local communities and abroad.

In fiscal year 2020-21, The Rotary Foundation (Canada) Programs Committee approved funding from Global Affairs Canada to be utilized towards Global grants supporting the "Partnership for Community Development" initiative. During the year, a total of \$1,354,283 (\$1,375,161 in FY20) from Global Affairs Canada was approved to be utilized towards Global grant projects.
