Project/Grant Description for Hilltop Recovery Ministries:

Hilltop Recovery Ministries (HRM) is a 501(c)3 Bell County organization that has served the needs of women who have experienced situations such as abuse, substance addiction, homelessness, human trafficking, et. al. via their drop in, day programs since 2012. HRM is now working towards providing live in services to women in need.

With the help of the county, HRM has secured the former Cora Anderson Building on S. 9th in Temple. Having already secured funding via a grant, the Director of HRM, Tanya Roper, LCSW and her board, plan to renovate the building to house up to 10 women in need of services. HRM also plans to continue to offer drop-in day programs and counseling for women in need within the community.

Ms. Roper has requested assistance from Altrusa in purchasing items needed for daily living. Altrusans toured the site and feel that providing items to outfit a kitchen with appliances, cooking utensils, dishes, pots/pans, etc., dining tables and chairs and book shelves (and books) for a library would greatly benefit both HRM and the residents who receive services at HRM.

We estimate that the purchase and delivery of 5 large appliances (refrigerator, stove/oven, dish washer & microwaves x2) will cost around \$2300.00 (including tax and delivery). The balance of \$1700.00 would allow Altrusans to fulfill additional requests in the kitchen, dining area &/or library. Attached, you will find information on the large appliances selected.

We anticipate this being a one day project with Altrusans volunteering their time to unload small appliances and kitchen items, assemble furniture and decorate the kitchen, dining and parts of the library areas. Also needed would be assistance with moving boxes from the former program site to the Cora Anderson Building.

After having discussed the present and future needs of the HRM with the Director, we anticipate that Altrusa would be able to further help assist HRM residents with classes on: budgeting, resumé building, info. on home ownership, art classes, journaling, mentoring, etc.

Altrusa empowers its members to empower others. What better way to empower women who've faced an onslaught of hardship by empowering them through Hilltop Recovery Ministries?
