Speaker Biographies

In order of appearance at PETS

Past Rotary International President Rick King

Richard D. King is a past world president of Rotary International, and the senior partner in the California law firm King, King & King. He earned undergraduate and law degrees from the University of California at Berkeley where he is a member of the California Club and the Order of



the Golden Bear. He taught law at Brigham Young University. He is a distinguished military graduate of the University of California and served as captain in the U.S. Military Intelligence. He received an Honorary Doctorate in Law from Hanyang University, Seoul, Korea.

A Rotarian since 1968, he is a member of the Rotary Club of Niles-Fremont, California USA. He has served as a trustee of The Rotary Foundation, director and as chairman of the executive commit-

tee of Rotary International's board of directors. He has also served Rotary as a club president, district governor, an international assembly instructor and an official representative of the president of R.I. He has chaired and served on many Rotary International committees, task forces and special assignments. Mr. King has received the Rotary Citation for Meritorious Service and the Distinguished Service Award for his support of humanitarian and educational programs of the Rotary Foundation. He is a recipient of the PolioPlus Pioneer Award.

One of Rotary's most popular speakers, Mr. King has addressed Rotary International Conventions, Assemblies, Institutes, Seminars, Conferences and Rotary Clubs in every state in the USA and some 100 countries. As President, he led Rotary International to its greatest one-year growth record in its 100-year history, with 75,000 New Members Net, a global membership of 1,243,431 and 1,158 New Rotary Clubs in 2001-2002, more than one new club every 8 hours. In the same year, Rotarians contributed the highest amount of money ever raised for the Annual Fund of the Rotary Foundation.

Mr. King is married to Cherie Kay King. They have two grown sons and reside in the Mission San Jose area of the San Francisco, California Bay Area.

Rotary International Director Julia Phelps

Julia joined the Rotary Club of Amesbury, MA in 1997, thanks to Brad Ford, and served as president of the club in 2001-02. She was very active in the Rotary Youth Leadership Awards (RYLA) program and hosted several Ambassadorial Scholars. After serving as president, she was asked to train incoming presidents at NE Presidents-elect Training Seminar (PETS). Julia served as a host counselor for a Youth Exchange and is currently a member of the Rotary Club in Malden, MA.



She has served in several positions at the District level. She worked on RYLA, served as Inbound Chair for Ambassadorial Scholars and was District Governor of District 7930 in 2007-2008. She was the District's Annual Giving Chair and the Chair for NE PETS. Julia became District 7930's Foundation Chair in July 2009 and led the district through the Future Vision Pilot. She shared Future Vision insights at the International Conventions in New Orleans, Louisiana and Lisbon,

Portugal.

Julia served as a Presidents Representative and the Rotary Foundation Alumni Chair (RFAC) for Zone 32 from 2009 - 2012. Julia accepted the appointments from the Rotary Foundation Trustees to train Governors-elect at the International Assembly in 2012 and again in 2013.

Julia is the recipient of the Citation for Meritorious Service presented by the Trustees of the Rotary Foundation. Steve McKenzie, her husband, and Julia are Majors Donors and charter members of the Bequest Society. She is also a Paul Harris Society member.

She is retired from the Massachusetts Department of Elementary and Secondary Education where she served as the Associate Commissioner for Curriculum and Instruction. She and Steve, who is also a Rotarian, live in Greenland, New Hampshire and are the owners of the 1810 Pickering House Bed and Breakfast. Steve is the proud father of two children, Melissa and Stephen. Steve and Julia are also the grandparents to Peyton, Zeth, River, Finn and Nate. All of their family members are Paul Harris Fellows.

Past Rotaract President Christa Papavasiliou

Christa Papavasiliou joined the Rotary family in 2009 after being invited to attend her local RYLA. Christa fell in love with the concept of putting service above self and was invited to represent Canada as a delegate at



iRYLA in Montreal during RICON 2010. Since then, Christa felt the urge to give back to the Rotary community which invested in her and has helped charter multiple Rotaract Clubs in Canada and the US.

Christa has travelled to five continents to give presentations to local Rotaract Clubs and attend

conferences to help promote the life changing work that Rotary does and help millennials take the leap to becoming Rotarians. In 2014, when Christa served as President to the Boston Rotaract Club, they received the prestigious Outstanding Rotaract Project of the Year Award from RI for a water filtration project they did in Guatemala.

Today, Christa serves as the Rotaract Chair for D7930 and looks forward to reuniting with her international family again at this coming RICON in Seoul, South Korea.

Rotary International Polio Plus Chair Mike McGovern

Mike McGovern joined Rotary in 1986 as a member of the Rotary Club of South Portland-Cape Elizabeth, Maine, USA. He has served as club president, district governor, district foundation chair, Rotarian Action Group chair, international training leader, RI committee member and chair,



director of Rotary International and vice president of Rotary. He has served in numerous other positions at the district, zone and international levels and has attended four Councils on Legislation in various roles.

He is currently in his final four months of a four-year term as a trustee of the Rotary Foundation. He serves as chair of the International PolioPlus Committee and vice chair of the Foundation Stewardship Committee. He also represents Rotary on the Polio Strategy Committee and the Legacy Management Group of

the Global Polio Eradication Initiative. Mike will continue with his polio responsibilities this coming Rotary year.

Mike has worked his entire career with the Town of Cape Elizabeth, Maine beginning as an intern in 1977 and serving as town manager since 1985. He appreciates the public spiritedness of successive town councils who have been supportive in providing him time to participate in Rotary activities.

He is a Major Donor to the Rotary Foundation and a recipient of the Rotary Foundation's Citation for Meritorious Service.

Rotary International Director-Elect Dean Rohrs

Dean, her husband Rhino and their three children emigrated to Canada from South Africa 26 years ago. Dean grew up in Zambia and after marrying Rhino lived in Malawi, Namibia and South Africa. Dean was born into a Rotary family and when Rhino joined Rotary in 1986 became an active Rotary Ann until she joined Rotary in 1989. On arriving in Van-



couver both Dean and Rhino joined the Rotary Club of West Vancouver, and, at present, are members of the Rotary Club of Langley Central in District 5050.

Dean has had a varied career from the early days of being an Operating Room Nurse on Professor Christiaan Barnard's first heart transplant team to running a Nursery School in Malawi. Together with Rhino, they now owner manage a company that is involved in soil stabilization during road construction.

Dean has served on District and Zone committees which include: Regional Rotary Coordinator and Regional Rotary Foundation Coordinator, Pacific Northwest PETS Chair and District Governor in 2007/2008 and will be stepping in as Rotary International Director 2016-2018.

However, her best experience is leading teams of Rotarians, Rotaractors and Interactors to Africa and seeing how this volunteer experience changes their lives.

Peace Fellow D. F. Pace

An attorney and lieutenant with the fourth-largest police department in the country, D. F. Pace focuses on balancing constitutional law and civil rights with public safety. He currently serves as the Commanding Officer of the Philadelphia Police Department's Law and Criminal Procedure



Unit; primarily dedicated to training police personnel in the areas of law and ethics and representing the department in legal matters. Lieutenant Pace is a fourteen-year veteran of the Philadelphia Police Department, having served in patrol as an officer, sergeant and shift commander.

In addition to his patrol experience, Pace has also served as Judge Advocate, Police Academy Instructor, and Deputy Public Information Officer.

Prior to embarking on a career in law enforcement, D.F. spent eight years as a corporate trainer for one of the nation's largest financial institutions, PNC. Travelling across the country, his primary mission was to train the organization's front-line supervisors in leadership skills, human resource management, and delivering world-class service to clients.

D.F. is no stranger to the lectern. An active and veteran adjunct professor, he has taught dozens of graduate and undergraduate courses at several universities. In addition to logging thousands of hours in front of college students and police recruits, Pace is a three-time champion of the Pennsylvania Bankers Association Annual Public Speaking Contest. Pace holds a Juris Doctorate from the James E. Beasley School of Law at Temple University and a Bachelor's Degree in Human Resource Management from Rosemont College. He is a member of the Bar in Pennsylvania and New Jersey. He is a graduate of the 256th session of the FBI National Academy and was the class's commencement speaker.

Among his most memorable and meaningful experiences, Pace spent four months at Chulalongkorn University in Thailand where he earned a professional certificate in Peace and Conflict Studies. From there, he traveled extensively, studying firsthand the impact of corporate globalization, labor exploitation, international and transnational crimes of terrorism, drug distribution, and human trafficking.

D.F.'s interests include physical fitness, animal welfare and sustainability issues. He is an avid supporter of Rotary International and a member of several other fraternal organizations.



O say can you see, by the dawn's early light, What so proudly we hailed at the twilight's last gleaming, Whose broad stripes and bright stars through the perilous fight, O'er the ramparts we watched were so gallantly streaming? 


