

## Safety Protocols for the 2021 HCDJLS Show

- Masks will be required on the show grounds at all times per Governor's Executive Order. Masks will be worn by show volunteers, exhibitors, parents and ag teachers/extension agents as well as any other essential persons.
- Social Distancing will be encouraged and enforced at all times.
- Numbers will be limited by only allowing each exhibitor's family (2 parents or guardian) into the show. Each exhibitor and family member will be issued a wrist band and others will not be allowed entry into the show.

## Health Screenings

- Parents/guardians/ag teachers or extension agents are expected to <u>screen their exhibitor</u> for COVID-19 symptoms each day prior to sending them to the show.
- Parents/guardians, ag teachers or extensions and other essential persons are expected to self-screen for COVID-19 symptoms each day prior to attending the show.

When screening whether an individual has symptoms consistent with Covid-19, we will consider the following question:

Has the individual recently begun experiencing any of the following in a way that is not normal for them?

- Feeling feverish or a measured temperature greater than or equal to 100.0 degrees
- Loss of taste or smell
- Cough
- Difficulty Breathing
- Shortness of Breath
- Headache
- Chills
- Sore throat
- Congestion or runny nose
- Shaking or exaggerated Shivering
- Significant muscle pain or ache
- Diarrhea
- Nausea or vomiting



#### **Isolation Protocols**

#### Anyone experiencing COVID-19 Symptoms

- When any person displays symptoms of COVID-19, they should be separated from their peers and should be removed from the show grounds in a timely manner.
- <u>Any persons</u> who are lab-confirmed with COVID-19 will be unable to return to the show. <u>This will fall under our current substitution rules for the show.</u>
- Any person who come into close contact with an individual who is lab-confirmed with COVID-19 will be required to self-quarantine for 14 days and may not return to the show during that time.

### **Close Contact**

" Close contact" with an individual who is lab-confirmed to have COVID-19 is defined as:

- being directly exposed to infectious secretions (e.g., being coughed on); or
- being within 6 feet for a cumulative duration of 15 minutes

If either occurred during the infectious period of the case, defined as two days prior to symptom onset to 10 days after symptom onset. In the case of asymptomatic individuals who are lab-confirmed with COVID-19, the infectious period is defined as two days prior to the confirming lab test and continuing for 10 days following the confirming lab test.

# **Cleaning Protocols**

- Frequently wiping commonly touched areas
- Touch free hand sanitizer dispensers stationed around the show grounds

## **Protective Measures**

#### General

- Use hand sanitizer before entering the show grounds
- Increase hygiene awareness and handwashing during the day
- Limit sharing (when feasible)
- Follow social distancing guidelines whenever possible
