Today's Program - Tom Mauro introduced Harlan E. Rubottom, C.P.A., as our speaker this morning. Harlan, also Harley, provided us with some important tax law changes brought about by the Tax Act of 1984 and the Retirement Equity Act of 1984 that apply to both 1984 and 1985. As with any of the Lawyers' and Accountants' Relief Acts, there's some good news and some bad news. Although 1984 is the last year of the 1981 income tax reduction, divorce property settlements after July 18, 1984, are not taxable. However, Pension and Profit Sharing Plans can be

invaded to satisfy any delinquent maintenance or child support payments deemed to be in arrears by a court having jurisdiction of a Dissolution of Marraige action. Investment tax credit on certain vehicles and "listed property" after June 18, 1984, will be limited. For 1985 there is legislation now in Congress that would eliminate state and local income taxes and sales or property taxes from deductible income, energy tax credits for years after 1985 have already been eliminated, and further restrictions have been placed on the contributon and eligibility regulations that govern corporate pension and profit sharing plans.

I think it is a given that a bureaucratic federal government in Washington, D.C. that escalates spending must escalate taxation to pay for it or create an inflated dollar. Since neither the Congress nor the President will back down the growth of the government sector, spending will go unchecked. Any government that spends money that goes sky-rocketing can either raise taxes or reduce spending. I think most people would prefer the later. I voted for Reagan, too, but I remember him in early times..., saying General Electric - progress is our most important product. Not any more. What Ike feared the most - the accelerating power and domination of the military sector - is with us now. I guess since we aren't perfect we expect our government to be perfect...and not God. Any bureaucracy feeds on itself...... and eventually dies. Amen for this week.
