


Shining Light on the Cosmopolitan Club's Activities

Deb Daughters, Led the Members in Prayer.
















President Elect Becky Kerr Introduced Rapid City Mayor Jason Salamun.




Mayor Jason Salamun talked to the Members about the Vision Funds for the City of Rapid City focusing on four key areas of the city during the next four years. He is planning on having a training building for police and fire departments. This would be available for units in Western South Dakota.



Those areas are community projects, economic development, comprehensive plan priorities, and strategic growth revolving funds.


One of the newer ideas proposed in the 2025 to 2029 closer look at the Vision Funds is a non-profit endowment.

The mayor is proposing to invest \$1.3 million in this section of community projects as a way for non-profits to work closer with the city ... making it easier for those organizations to get funded.




One idea that was presented to him was the non-profit endowment, and we set some money aside so that non-profits can perhaps have matching funds for their capital projects down the road. So, this is kind of that seed money to get that going," said Rapid City Mayor Jason Salamun.

The section with the biggest funding was comprehensive plan priority projects, seeing 29.5% of the Vision Funds a total of \$26.8 million that could be allocated to quality of life projects, public safety, and city fleet maintenance.



He has instructed Jeff Biegler, our parks and recreation director, to bring some projects forward—it's not ready for prime time—into that comprehensive plan, so it's part of a plan, it is part of a strategy, and that when we go to fund it, we can go back and say this is part of a plan.


Community Projects - 25% Economic Development - 23.5% Strategic Growth Revolving Funds - 22%

### ORIGINS OF THE VISION FUND

- 1972, Rapid City voters approved sales tax increase
  - Purpose was to pay for a new civic center facility
- 1977 Civic Center opened
- 1995 voters supported continuing the sales tax
  - The sales tax funded a series of significant projects that enhanced the quality of life in the community - "The Vision Fund"







#### COMMUNITY PROJECTS

- 25% of the Vision Fund Budget
  - \$16.4 Million Towards Arena Bonds
  - \$5 Million Toward Citizen-Recommended Project(s)
  - \$1.3 Million Non-Profit Endowment
    - In time, this will create a stable means to help non-profit capital projects







#### ECONOMIC DEVELOPMENT

- 23.5% of the Vision Fund Budget
  - \$16.4 Million Towards Arena Bonds
  - \$5 Million in Economic Development Efforts







#### COMPREHENSIVE PLAN PRIORITY PROJECTS

- 29.5% of the Vision Fund Budget
- \$26.8 Million toward Comprehensive Plan Implementation
- Examples:
  - Parks and Recreation Projects
  - Public Safety Training Center
  - Fleet Maintenance Facility








