Lone Star PETS 2023 Online Registration Guide

The Lone Star President-Elect Training Seminar (PETS) is designed to provide essential and current information to President-elects and President-nominees to prepare them to have an effective and successful year. Attendees will have the opportunity to hear talks by top Rotary leaders and motivational speakers, attend small group discussion sessions on various topics led by knowledgeable and experienced discussion leaders and network and exchange ideas with their peers from ten Rotary districts.

I know that you will find Lone Star PETS to be a *very* worthwhile training experience and this guide has been developed to provide you with the information you need to know <u>before</u> going online to register.

1. Registration Packages

Registering for Lone Star PETS is easy!

Go to the Lone Star PETS website at <u>www.lonestarpets.org</u> and click on "Registration" in the menu, then "Online PETS Registration Link" in the drop down. This will take you directly to the Lone Star PETS registration page.

If you have a Club Runner login enter your login and password. This will prefill some of your information. If you do not have a Club Runner login enter your information. You will then be required to choose a registration package.

Be sure to indicate your **role at PETS** on the first page of registration.

The five available **Registration Packages** options are as follows:

- **a. President-elect**: Select this option if you will serve as the President of your club starting <u>July 1, 2023.</u>
- **b. President-nominee**: Select this option if you will serve as the President of your club starting <u>July 1, 2024.</u>
- c. Assistant Governor: Select this option if you are an Assistant Governor.
- **d. Spouse/Partner:** Select this option if you are a Spouse or Partner of someone attending PETS as a President-elect, President-nominee, DG, DGE, DGN, PDG, AG, DRFC, Facilitator, or Lone Star PETS staff member.
- **e. All Others:** Select this option if you do not fit into one of the other four categories. This category includes DGs, DGEs, DGNs, PDGs, DFRCs, Facilitators, Rangers and other Lone Star PETS staff.

All options include the Elective classes and the Keynote Speakers each day.

<u>Note:</u> Please understand that if you (excluding PEs, PNs, and Facilitators) and/or your spouse/partner want to participate in either the AG Training or the Spouse/Partner Program you <u>MUST</u> register for the appropriate Registration Package.

<u>Hint:</u> If you fit into more than one Registration Package option, choose the option that best describes **why you're attending PETS** For instance, if both you and your spouse

are attending, and both of you are either a President-elect or President-nominee, choose that option over Spouse/Partner.

2. Registration

Note: Online registration will open on November 1, 2022, and run through midnight February 22, 2023.

3. Thursday Evening Classes

When you register for PETS, you will be given the opportunity to register for **up to two Thursday evening** classes led by knowledgeable and experienced facilitators that are designed to provide focused information on a variety of Rotary subjects. These classes will be presented twice, one at 7:00-7:50 and again at 8:00-8:50. Please only sign up for one class at 7:00 pm and a different class at 8:00 pm. The Spouse/Partner Reception and Interactive ShelterBox Experience classes are only offered once.

Course Description of Thursday Evening Classes

Spouse/Partner Reception

This reception serves as the introduction to the Spouse/Partner activities during PETS. Facilitators: Susie and Clete McAlister

Interactive ShelterBox Experience

The Interactive ShelterBox Experience is a unique way to learn about ShelterBox. Take an interactive approach at some difficult decisions ShelterBox must make every day and share ideas on what your Rotary club can do to help your neighbors be prepared.
