# Lone Star PETS 2024 Online Registration Guide

The Lone Star President-Elect Training Seminar (PETS) is designed to provide essential and current information to President-elects and President-nominees to prepare them to have an effective and successful year. Attendees will have the opportunity to hear talks by top Rotary leaders and motivational speakers, attend small group discussion sessions on various topics led by knowledgeable and experienced discussion leaders and network and exchange ideas with their peers from ten Rotary districts.

I know that you will find Lone Star PETS to be a *very* worthwhile training experience and this guide has been developed to provide you with the information you need to know <u>before</u> going online to register.

#### 1. Registration Packages

Registering for Lone Star PETS is easy!

Go to the Lone Star PETS website at <u>www.lonestarpets.org</u> and click on "Registration" in the menu, then "Online PETS Registration Link" in the drop down. This will take you directly to the Lone Star PETS registration page.

If you have a Club Runner login enter your login and password. This will prefill some of your information. If you do not have a Club Runner login enter your information. You will then be required to choose a registration package.

Be sure to indicate your **role at PETS** on the first page of registration. Registration packages include all meals.

The six available **<u>Registration Packages</u>** options are as follows:

- **a. President-elect**: Select this option if you will serve as the President of your club starting <u>July 1, 2024.</u>
- **b. President-nominee**: Select this option if you will serve as the President of your club starting <u>July 1, 2025.</u>
- c. Assistant Governor: Select this option if you are an Assistant Governor.
- **d. Spouse/Partner:** Select this option if you are a Spouse or Partner of someone attending PETS as a President-elect, President-nominee, DG, DGE, DGN, PDG, AG, DRFC, Facilitator, or Lone Star PETS Operating Committee.
- e. All Others: Select this option if you do not fit into one of the other four categories. This category includes DGs, DGEs, DGNs, PDGs, DFRCs, Facilitators, Rangers and other Lone Star PETS Operating Committee.
- f. Rotaractors: Select this option if you are a Rotaractor

All options include the Elective classes and the Keynote Speakers each day.

<u>Note:</u> Please understand that if you (excluding PEs, PNs, and Facilitators) and/or your spouse/partner want to participate in either the AG Training or the Spouse/Partner Program you <u>MUST</u> register for the appropriate Registration Package.

<u>**Hint:</u>** If you fit into more than one Registration Package option, choose the option that best describes **why you're attending PETS** For instance, if both you and your spouse are attending, and both of you are either a President-elect or President-nominee, choose that option over Spouse/Partner.</u>

# 2. Registration

<u>Note</u>: Online registration will open on November 1, 2023 and run through midnight February 23, 2024.

# 3. Thursday Evening Classes

When you register for PETS, you will be given the opportunity to register for **two Thursday evening** classes led by knowledgeable and experienced facilitators that are designed to provide focused information on a variety of Rotary subjects. Most of these classes will be presented twice, one at 7:00-7:50 and again at 8:00-8:50. The Reception for Rotarian Spouses/Partners, Avoiding Legal Landmines: Club Liability for General Operation, Events, and Raffles, 10 Easy Steps to Energize Clubs with Rotary Foundation Programs, ClubRunner Essentials and ClubRunner Advanced will only be offered once.

# **Course Description of Thursday Evening Classes**

## **Reception for Rotarian Spouses/Partners**

This session is an informal reception for the purpose of meeting fellow participants who registered for the PETS Spouses/Partners program. It will include a general discussion of the Spouse/Partner program offered on Friday and Saturday. Facilitators: Susie McAlester and Clete McAlester

# 10 Easy Steps to Energize Clubs with Rotary Foundation Programs

Learn the key steps (not technical ingredients) for a successful Club President to involve their Rotary Club with the activities and programs of The Rotary Foundation. ## Holding Stimulating and Effective Board Meetings and Club Assemblies

#### **ClubRunner Essentials**

Includes how to login, navigate the website and will be covering features such as access level requirements for editing various areas of the website. We will also demonstrate how to upload the new executive team. We will cover auto-integration with Rotary International. Finally, the course will demonstrate use of ClubRunner email, contacts lists and club document storage.

#### **ClubRunner Advanced**

Course covers Website Designer and the use of Event Management (including event registration, payment, volunteers, and invitations), the membership success program ad reports such as member activity (Participation Points) and club activity.

#### **Assistant Governor Training**

If you are registering for PETS as an Assistant Governor in order to support your District Governor-elect with Friday's training, please consider staying an extra day to attend Assistant Governor Training on Saturday. Whether you will be a first-time AG or have been on the job for a number of years, there's something in this training for everybody. Led by a knowledgeable and experienced discussion leader, you will network and exchange ideas with Assistant Governors from ten Rotary districts.
