

Canadian Trade & Tariffs

Insight from the Executive Council of Alberta



Join your CCE colleagues and Past Deputy Premier Thomas Lukaszuk for a conversation about the history of Canadian trade agreements & the impacts that tariffs will have on Canada and United States. Following his luncheon presentation, Thomas is happy to answer any questions.

About our speaker: The Honourable Thomas Lukaszuk served as a Member of the Legislative Assembly of Alberta from 2001 – 2015 on behalf of Edmonton-Castle Downs. He served on and/or chaired 23 legislative and policy government committees in the areas of accountability, access to information and ethics, support for low-income and disabled Albertans, tourism marketing, and human rights; held various Ministries throughout 2010-2014, including Minister of Jobs, Skills, Training and Labour, Minister of Enterprise and Advanced Education, Minister of Education, and Minister of Employment and Immigration; and acted as Deputy Premier from 2012 to 2014. He's an Honourary Member of Executive Council of Alberta (ECA), holds a Bachelor of Education (B.Ed.) from the University of Alberta, and has designation with the Institute of Corporate Directors (ICD.D).

Thomas currently serves on the Boards of: Alberta Safety Council, No Stone Left Alone, Polish Canadian Historical Society, and is Co-Founder to Castle Downs Recreational Society International.

Did you know? The Association of Canadian Clubs was chartered by an Act of Parliament in 1939. The first Club was founded in 1893 in Hamilton, by leading Canadian citizens who were worried about the lack of patriotism in the country at that time. Canada was thought to have lost its direction. Sir John A Macdonald had passed away and the young country struggled with four Prime Ministers in five years. Railway expansion had slowed, the economy was in the doldrums and there was little agreement on Canada's future. The needed injection of patriotism came from Charles McCullough and a group of his friends who formed the first Canadian Club. Clubs soon were organized from coast to coast (Edmonton 1906).
