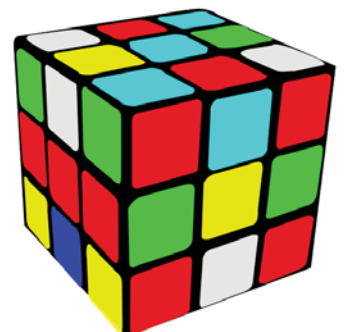

## Your Role in Identifying Domestic Abuse

Informal sources of social support are often sought first by people living in situations of Intimate Partner Violence (IPV). Dentists are one example of an informal source of support. People tend to form a relationship with their dentist and it is this relationship that allows for a comfort level for disclosures of IPV. The response a client receives from a dentist upon disclosure can directly influence further action a client will take, such as seeking more formal forms of support. Therefore, it is important for dentists to have the knowledge and tools to respond in a safe, effective, and compassionate way to disclosures of IPV.

### ABOUT MMFF

The Muriel McQueen Fergusson Centre for Family Violence Research (MMFC), has developed Community of Practice Training on IPV for a variety of professional groups. The Training is intended for those who are not working directly with victims, violent partners, children and/or witnesses of IPV but who are likely to receive disclosures from their clients. The training provides participants with an understanding of the dynamics of IPV, what it is, why it occurs, the impact it has on the lives of individuals, including victims, children and violent partners and how to respond to disclosures of IPV.

## Income Splitting and Passive Investment Rules

## Practice Dentistry Pain-Free Evidence-Based Strategies For A Long & Healthy Career

This research-based seminar for dentists, specialists, hygienists, and assistants bridges the gap between dental ergonomics and work-related pain so you can work more comfortably and productively. Delivered with high energy and humor, attendees will discover how equipment selection & adjustment, patient positioning, lighting, movement and operator layout are affecting their health. Engaging demonstrations help attendees learn how to implement powerful evidence-based strategies to prevent work-related pain and improve quality of life.

### COURSE CONTENTS:

- Understand the etiology of work-related pain in dentistry to make health-wise choices in the operatory & at home.
- Identify and implement appropriate ergonomic interventions for chronic back, neck & shoulder pain.
- Identify the 3 essential ergonomic criteria for selecting loupes that will improve health — not make it worse!
- Properly select and adjust delivery systems, stools and chairs depending on operator size & job-type
- Make ergonomic modifications in the operatory with minimal expense.
- Discover the newest guidelines for positioning patient, headrest and light to treat various arches and quadrants.
- Learn 4 strategies for properly positioning the dentist with the assistant chairside.
- Learn the unique muscle imbalances to which dental professionals are predisposed.
- Discover how certain movement patterns in the operatory can cause shoulder & spine dysfunction.

## Implant Treatment Options for Missing Posterior or Anterior Teeth

The first part of this session will be dedicated to developing a better understanding of the different treatment options for missing posterior teeth. In the second half, we will focus on describing single and partial (for two or more teeth) treatment options for anterior teeth. We will conclude with a review of the different processes for monitoring (radiologic scans of the muco-gingival complex) and proper hygiene for implants.

## Medical Cannabis: Common Uses and What You Need to Know

The government of Canada will soon be legalizing the use of cannabis. Currently, cannabis is the most frequently used illegal drug in Canada and the United States. Medical cannabis is becoming more widely accepted as a medication to help with mental and physical health, which means the number of people being prescribed medical cannabis is rising. The main reason for prescriptions of the drug is to help with pain or pain management. Issues such as severe headaches or migraines, cancer, and long-term conditions can be improved with the use of the drug.

Cannabis use has been shown to increase the risk of developing tooth loss and gum disease. It may also cause xerostomia and orthostatic hypotension. While the oral health effects may be easily detected, managing patients who use medical cannabis is a skill that your dental team will need to develop. What other considerations need to be taken into account if you are going to sedate your patient for treatment? Are there additional risks or side effects for which you need to be prepared? What responsibility does your office have towards a patient using medical cannabis?

*Dr. Andrea Burry is the Medical Director of Trauma Healing Centers. Over the course of her practice, Dr. Burry has developed interests in Occupational Medicine and most recently in medical cannabis and the role that it can play in treating conditions such as post-traumatic stress disorder and chronic pain.*
